

OKEECHOBEE COUNTY SCHOOL BOARD POLICY

In accordance with the Administrative Procedures Act, Chapter 120, Florida Statutes, notice is hereby given that the Okeechobee County School Board will consider amendment or adoption of the School Board policies listed below at their meeting on Thursday, July 21, 2022, at 6:00 p.m., in Room 303 of the School Board Administrative Office at 700 S.W. 2nd Avenue, Okeechobee. Copies of the proposed amendment or adoption are available in the Superintendent's Office, Room 307, 700 S.W. 2nd Avenue, Okeechobee.

Amendment of Board Policy 3.14+ *Suicide Prevention*

- I. This policy defines the School Board's commitment to protecting the health, safety and welfare of its students and school community by instituting plans and procedures to prevent suicide.
- II. The proposed policy is recommended to clarify the time period for certification.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are F.S. 1003.42 and 1012.583.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Student Progression Plan* – Board Policy 4.20

- I. The *Student Progression Plan* is included in School Board Policy 4.20 Student Progression Plan.
- II. Proposed revisions bring the plan into compliance with Legislative changes from the 2022 session and amends the grade calculations for elementary courses.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42, 1002.20, 1002.45, 1003.436 and 1008.22. Laws implemented are 1001.43, 1002.3105, 1002.321, 1003.4156, 1003.4281, 1003.4295, 1003.437, 1003.49, 1008.25, F.S. Florida Administrative Code 6A-1.09963 and 6A-1.09963.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Code of Student Conduct* Board Policy 5.40 Student Control

- I. This policy includes the Code of Student Conduct.
- II. The proposed provisions bring the Code into compliance with Legislative changes from the 2022 session and amends consequences for certain infractions.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are F.S. 120.57(1), 1001.43, 1002.20, 1003.04, 1003.21, 1003.31, 1003.32, 1006.07, 1006.08, 1006.09, 1006.10, 1006.13; State Board of Education Rules 6A-1.0404.
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of *Notification of Involuntary Examination* Board Policy 5.55*+

- I. This policy provides guidelines for immediate parent notification when a student is taken for an involuntary examination.
- II. The proposed revision is required by Legislation.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 381.0056, 394.463, 1001.21, 1002.20, 1006.062, F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.
