RESOLUTION

A RESOLUTION OF THE OKEECHOBEE COUNTY SCHOOL BOARD, FLORIDA, ADOPTING BOUNDARIES FOR EACH OF THE FIVE SCHOOL BOARD DISTRICTS.

Whereas, Okeechobee County is divided into five School Board districts of contiguous territory as nearly equal in population as practical, pursuant to the requirements of 1001.36, Florida Statutes; and

Whereas, Okeechobee County School Board shall from time to time fix the boundaries of the above districts so as to keep them as nearly equal in proportion to population as possible; and

Whereas, the 2020 federal census indicated that certain adjustments to the School Board district boundaries are warranted.

Now therefore, be it resolved by the Okeechobee County School Board, Florida, as follows:

1. <u>School Board District No. 1</u> (Commission District #4) shall consist of the following area located within Okeechobee County, Florida:

Beginning at the centerline of the intersection of Lake Okeechobee and Taylor Creek,

thence proceed Southwest on the centerline of Lake Okeechobee to the intersection of the centerline of South Western Okeechobee County Boundary,

thence proceed North on the centerline of South Western Okeechobee County Boundary to the intersection of the centerline of Western Okeechobee Boundary,

thence proceed Northwest on the centerline of Western Okeechobee Boundary to the intersection of the centerline of STR 29-37-34 Southern Boundary,

thence proceed East on the centerline of STR 29-37-34 Southern Boundary to the intersection of the centerline of STR 28-37-34 Southern Boundary,

thence proceed East on the centerline of STR 28-37-34 Southern Boundary to the intersection of the centerline of STR 27-37-34 Southern Boundary,

thence proceed East on the centerline of STR 27-37-34 Southern Boundary to the intersection of the centerline of Kissimmee River Feeder Ditch,

thence proceed Northwest on the centerline of Kissimmee River Feeder Ditch to the intersection of the centerline of State Hwy 70,

thence proceed East on the centerline of State Hwy 70 to the intersection of the centerline of SW 24th Avenue,

thence proceed South on the centerline of SW 24th Avenue to the intersection of the centerline of SW 8th Street,

thence proceed East on the centerline of SW 8th Street to the intersection of the centerline of SW 12th Avenue,

thence proceed South on the centerline of SW 12th Avenue to the intersection of the centerline of SW 12th Avenue Southern Extension,

thence proceed South on the centerline of SW 12th Avenue Southern Extension to the intersection of

the centerline of SW 15th Street,

thence proceed East on the centerline of SW 15th Street to the intersection of the centerline of SW 7th Avenue.

thence proceed North on the centerline of SW 7th Avenue to the intersection of the centerline of SW 15th Street,

thence proceed East on the centerline of SW 15th Street to the intersection of the centerline of SW 5th Avenue.

thence proceed South on the centerline of SW 5th Avenue to the intersection of the centerline of SW 15th Street,

thence proceed East on the centerline of SW 15th Street to the intersection of the centerline of SW 3rd Avenue,

thence proceed South on the centerline of SW 3rd Avenue to the intersection of the centerline of SW 16th Street,

thence proceed East on the centerline of SW 16th Street to the intersection of the centerline of S Parrott Avenue,

thence proceed North on the centerline of S Parrott Ave to the intersection of the centerline of NE Park Street.

thence proceed East on the centerline of NE Park Street to the intersection of the centerline of NE 6th Avenue.

thence proceed South on the centerline of NE 6th Avenue to the intersection of the centerline of NE Park Street,

thence proceed East on the centerline of NE Park Street,

thence proceed Southeast on the centerline of Taylor Creek,

ending at the centerline of the Intersection of Taylor Creek and Lake Okeechobee, ending at the beginning.

2. <u>School Board District No. 2</u> (Commission District #5) shall consist of the following area located within Okeechobee County, Florida:

Beginning at the centerline of the intersection of East Okeechobee County Boundary and State Hwy 70,

thence proceed South on the centerline of East Okeechobee County Boundary to the intersection of the centerline of South Eastern Okeechobee County Boundary,

thence proceed Southwest on the centerline of South Eastern Okeechobee County Boundary to the intersection of the centerline of South Western Okeechobee County Boundary,

thence proceed North on the centerline of South Western Okeechobee County Boundary to the intersection of the centerline of Lake Okeechobee,

thence proceed Northeast on the centerline of Lake Okeechobee to the intersection of the centerline of Taylor Creek,

thence proceed Northwest on the centerline of Taylor Creek to the intersection of the centerline of SE 28th Street - SE 27th Street Drainage Canal,

thence proceed Northeast on the centerline of SE 28th Street - SE 27th Street Drainage Canal to the intersection of the centerline of Mosquito Creek,

thence proceed Northeast on the centerline of Mosquito Creek to the intersection of the centerline of Extension Canal,

thence proceed Northwest on the centerline of Extension Canal to the intersection of the centerline of State Hwy 710,

thence proceed Northwest on the centerline of State Hwy 710 to the intersection of the centerline of State Hwy 710 to NE Park Street Off Ramp,

thence proceed Northwest on the centerline of State Hwy 710 to NE Park Street Off Ramp to the intersection of the centerline of NE Park Street,

thence proceed Northeast on the centerline of NE Park Street,

thence Proceed Northeast on the centerline of State Hwy 70,

ending at the centerline of the Intersection of State Hwy 70 and East Okeechobee County Boundary ending at the beginning.

3. <u>School Board District No. 3</u> (Commission District #2) shall consist of the following area located within Okeechobee County, Florida:

Beginning at the centerline of the intersection of S Parrott Avenue and NW Park Street,

thence proceed South on the centerline of S Parrott Avenue to the intersection of the centerline of SW 16th Street,

thence proceed West on the centerline of SW 16th Street to the intersection of the centerline of SW 3rd Avenue,

thence proceed North on the centerline of SW 3rd Avenue to the intersection of the centerline of SW 15th Street,

thence proceed West on the centerline of SW 15th Street to the intersection of the centerline of SW 5th Avenue,

thence proceed North on the centerline of SW 5th Avenue to the intersection of the centerline of SW 15th Street,

thence proceed West on the centerline of SW 15th Street to the intersection of the centerline of SW 7th Avenue,

thence proceed South on the centerline of SW 7th Avenue to the intersection of the centerline of SW 15th Street,

thence proceed West on the centerline of SW 15th Street to the intersection of the centerline of SW 12th Avenue Southern Extension.

thence proceed North on the centerline of SW 12th Avenue Southern Extension to the intersection of the centerline of SW 12th Avenue,

thence proceed North on the centerline of SW 12th Avenue to the intersection of the centerline of SW 8th Street,

thence proceed West on the centerline of SW 8th Street to the intersection of the centerline of SW 24th Avenue,

thence proceed North on the centerline of SW 24th Avenue to the intersection of the centerline of State Hwy 70,

thence proceed West on the centerline of State Hwy 70 to the intersection of the centerline of Page 3 of 7

Kissimmee River Feeder Ditch,

thence proceed Southeast on the centerline of Kissimmee River Feeder Ditch to the intersection of the centerline of STR 27-37-34 Southern Boundary,

thence proceed West on the centerline of STR 27-37-34 Southern Boundary to the intersection of the centerline of STR 28-37-34 Southern Boundary,

thence proceed West on the centerline of STR 28-37-34 Southern Boundary to the intersection of the centerline of STR 29-37-34 Southern Boundary,

thence proceed West on the centerline of STR 29-37-34 Southern Boundary to the intersection of the centerline of Western Okeechobee Boundary,

thence proceed Northwest on the centerline of Western Okeechobee Boundary to the intersection of the centerline of North Okeechobee County Boundary,

thence proceed East on the centerline of North Okeechobee County Boundary to the intersection of the centerline of NW 192nd Avenue Northern Extension,

thence proceed South on the centerline of NW 192nd Avenue Northern Extension to the intersection of the centerline of NW 192nd Avenue,

thence proceed South on the centerline of NW 192nd Avenue to the intersection of the centerline of NW 240th Street,

thence proceed East on the centerline of NW 240th Street to the intersection of the centerline of NW 176th Avenue,

thence proceed South on the centerline of NW 176th Avenue to the intersection of the centerline of US Hwy 98,

thence proceed Southeast on the centerline of US Hwy 98 to the intersection of the centerline of Northern Basswood Estates Boundary,

thence proceed East on the centerline of Northern Basswood Estates Boundary to the intersection of the centerline of NW 26th Avenue,

thence proceed South on the centerline of NW 26th Avenue to the intersection of the centerline of NW 36th Street,

thence proceed West on the centerline of NW 36th Street to the intersection of the centerline of NW 27th Avenue,

thence proceed South on the centerline of NW 27th Avenue to the intersection of the centerline of Okeechobee County Airport Perimeter,

thence proceed Southwest on the centerline of Okeechobee County Airport Perimeter to the intersection of the centerline of US Hwy 98,

thence proceed Southeast on the centerline of US Hwy 98 to the intersection of the centerline of NW 6th Street,

thence proceed East on the centerline of NW 6th Street to the intersection of the centerline of NW 12th Avenue,

thence proceed South on the centerline of NW 12th Avenue to the intersection of the centerline of NW 12th Avenue Southern Extension,

thence proceed South on the centerline of NW 12th Avenue Southern Extension to the intersection of the centerline of State Hwy 70,

thence proceed East on the centerline of State Hwy 70,

thence proceed East on the centerline of NW Park Street,

ending at the centerline of the Intersection of NW Park St and S Parrott Avenue, ending at the beginning.

4. School Board District No. 4 (Commission District #3) shall consist of the following area located within Okeechobee County, Florida:

Beginning at the centerline of the intersection of State Hwy 70 and East Okeechobee County Boundary,

thence proceed Southwest on the centerline of State Hwy 70 to the intersection of the centerline of NE Park Street,

thence proceed Southwest on the centerline of NE Park Street to the intersection of the centerline of State Hwy 710 to NE Park Street Off Ramp,

thence proceed Southeast on the centerline of State Hwy 710 to NE Park Street Off Ramp to the intersection of the centerline of State Hwy 710,

thence proceed Southeast on the centerline of State Hwy 710 to the intersection of the centerline of Extension Canal,

thence proceed Southeast on the centerline of Extension Canal to the intersection of the centerline of Mosquito Creek,

thence proceed Southwest on the centerline of Mosquito Creek to the intersection of the centerline of SE 28th Street - SE 27th Street Drainage Canal,

thence proceed West on the centerline of SE 28th Street - SE 27th Street Drainage Canal to the intersection of the centerline of Taylor Creek,

thence proceed Northwest on the centerline of Taylor Creek to the intersection of the centerline of NE Park Street,

thence proceed West on the centerline of NE Park Street to the intersection of the centerline of NE 6th Avenue.

thence proceed North on the centerline of NE 6th Avenue to the intersection of the centerline of NE Park Street.

thence proceed East on the centerline of NE Park Street to the intersection of the centerline of Taylor Creek,

thence proceed North on the centerline of Taylor Creek to the intersection of the centerline of NE 39th Boulevard,

thence proceed Northeast on the centerline of NE 39th Boulevard to the intersection of the centerline of Eastern Township 35 Range 36,

thence proceed North on the centerline of Eastern Township 35 Range 36 to the intersection of the centerline of NE 144th Street,

thence proceed West on the centerline of NE 144th Street to the intersection of the centerline of N Parrott Avenue,

thence proceed Northeast on the centerline of N Parrott Avenue to the intersection of the centerline of NW 240th Street,

thence proceed West on the centerline of NW 240th Street to the intersection of the centerline of 72nd Avenue,

thence proceed North on the centerline of 72nd Avenue to the intersection of the centerline of 72nd Avenue Northern Extension,

thence proceed North on the centerline of 72nd Avenue Northern Extension to the intersection of the centerline of North Okeechobee County Boundary,

thence proceed East on the centerline of North Okeechobee County Boundary to the intersection of the centerline of North East Okeechobee County Boundary,

thence proceed Southeast on the centerline of North East Okeechobee County Boundary,

thence proceed South on the centerline of East Okeechobee County Boundary,

ending at the centerline of the Intersection of East Okeechobee County Boundary and State Hwy 70, ending at the beginning.

5. <u>School Board District No. 5</u> (Commission District #1) shall consist of the following area located within Okeechobee County, Florida:

Beginning at the centerline of the intersection of NE 39th Blvd and Eastern Township 35 Range 36,

thence proceed Southwest on the centerline of NE 39th Boulevard to the intersection of the centerline of Taylor Creek,

thence proceed South on the centerline of Taylor Creek to the intersection of the centerline of NE Park Street,

thence proceed West on the centerline of NE Park Street to the intersection of the centerline of NW Park Street.

thence proceed West on the centerline of NW Park Street to the intersection of the centerline of State Hwy 70,

thence proceed West on the centerline of State Hwy 70 to the intersection of the centerline of NW 12th Avenue Southern Extension,

thence proceed North on the centerline of NW 12th Avenue Southern Extension to the intersection of the centerline of NW 12th Avenue,

thence proceed North on the centerline of NW 12th Avenue to the intersection of the centerline of NW 6th Street,

thence proceed West on the centerline of NW 6th Street to the intersection of the centerline of US Hwy 98.

thence proceed Northwest on the centerline of US Hwy 98 to the intersection of the centerline of Okeechobee County Airport Perimeter,

thence proceed Northeast on the centerline of Okeechobee County Airport Perimeter to the intersection of the centerline of NW 27th Avenue,

thence proceed North on the centerline of NW 27th Avenue to the intersection of the centerline of NW 36th Street,

thence proceed East on the centerline of NW 36th Street to the intersection of the centerline of NW 26th Avenue,

thence proceed North on the centerline of NW 26th Avenue to the intersection of the centerline of Northern Basswood Estates Boundary,

thence proceed West on the centerline of Northern Basswood Estates Boundary to the intersection of Page 6 of 7
