

## **OKEECHOBEE COUNTY SCHOOL BOARD POLICY**

In accordance with the Administrative Procedures Act, Chapter 120, Florida Statutes, notice is hereby given that the Okeechobee County School Board will consider amendment or adoption of the School Board policies listed below at their meeting on Tuesday, December 12, 2023, at 6:00 p.m., in Room 303 of the School Board Administrative Office at 700 S.W. 2nd Avenue, Okeechobee. Copies of the proposed amendment or adoption are available in the Superintendent's Office, Room 307, 700 S.W. 2nd Avenue, Okeechobee.

### **Adoption of Board Policy 4.35+ Artificial Intelligence Acceptable Use**

- I. This policy defines artificial intelligence use in education.
- II. The proposed adoption is recommended based on emerging technologies. Proactive based on HB 379.
- III. Legal authority for this policy is F.S. 1001.41, and 1001.42, F.S. Laws implemented are 1001.02, 1003.02, F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Adoption of Board Policy 4.36 Operation of Unmanned Aerial Vehicles (Drones)**

- I. This policy defines staff and students operation of drones.
- II. The proposed adoption is recommended to govern the use of drones on district property.
- III. Legal authority for this policy is F.S. 1001.41, and 1001.42, F.S. Laws implemented are 330.41, 934.50 F.S.; Title 49 U.S.C. §§40101, 40102 and 40103; 14 C.F.R. §§1.1; Federal Aviation Administration Advisory Circular AC 91-57A; Public Law 112-95; Code of Federal Regulation Part 107 – Small Unmanned Aircraft Systems; Florida High School Athletic Association Guideline Handbook.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 4.41\*+ Instructional Materials Selection**

- I. This policy defines the selection, approval, adoption and purchasing of instructional materials.
- II. The proposed amendment reflects Legislative and Rule updates incorporated; HB 1069 and Rule 6A-1.094126.
- III. Legal authority for this policy is F.S. 1001.41, and 1001.42, F.S. Laws implemented are 1001.43, 1006.28, 1006.29(5), 1006.31, 1006.32, 1006.40, F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 4.42\*+ Educational Media Materials Selection**

- I. This policy defines the criteria for selection and suitability of library materials.
- II. The proposed amendment reflects Legislative and Rule updates, HB 1069, Rule 6A-1.094126.
- III. Legal authority for this policy is F.S. 1001.41, and 1001.42, F.S. Laws implemented are 1000.21, 1001.43, 1006.28, 1006.34(2)(b), 1006.40, F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 5.28+ Children of Military Families**

- I. This policy includes general guidelines for assisting children of military families in transitioning between schools.
- II. The proposed revision reflects legislative changes; HB 633.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 1000.36, 1001.43, 1003.05, F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 5.32\* Zero Tolerance for School Related Crimes**

- I. This policy is required by Florida Statute.
- II. Proposed revisions reflects Legislative and Rule updates; HB 1537.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 120.57(1), 775.08, 784.081, 790.162, 790.163, 985.04, 1001.42, 1001.43, 1001.54, 1003.31, 1003.42, 1006.07, 1006.08, 1006.09, 1006.13, 1006.135, 1006.14, 1012.28 F.S.; State Board of Education Rules: 6A-6.03311
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 5.50+ Student Records Board**

- I. This policy lists general guidelines for student records and procedures to be included in the Student Educational Records Manual.
- II. The proposed revision reflects Legislative changes to HB 1 revising F.S. 1003.25 to transfer student records in 5 days instead of 3.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 119.07(1), 119.071, 1001.43, 1001.52, 1002.22, 1002.221, 1002.222, 1002.72, 1003.25, 1008.386, F.S.; 20 USC §1232g (34 CFR PART 99) P.L. 103-382 (34 CFR PART 99), 20 USC 1400 et. seq. Individuals with Disabilities Act, Privacy Rights of Parents and Students – P.L. 90-247. State Board of Education Rules: 6A-1.0955.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 6.58\* Report of Misconduct**

- I. This policy provides guidelines for reporting alleged employee misconduct that affects the health, safety, or welfare of a student.
- II. Proposed revisions reflect legislative changes in F.S. 1012.797.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 39.203, 112.313, 119.071, 768.095, 800.101, 1001.10, 1006.061, 1012.01, 1012.22, 1012.27, 1012.315, 1012.795, 1012.796, 1012.797 F.S.; State Board of Education Rules: 6A-10.081
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 8.11\* Emergency Evacuation Drills**

- I. This policy provides guidelines and requirements for emergency evacuation drills.
- II. The proposed amendment reflects Legislative and Rule Changes, HB 543; Rule 6A-1.0018
- III. Legal authority for this policy is F.S. 1001.41 and 1001.42. Laws implemented are F.S. 404.056, 1001.43, 1006.07, 1013.12 F.S.
- IV. This policy amendment will not affect individuals from an economic standpoint.
