**C. Introductory Statement – Chairman Arnold**

This is a hearing on the recommendation of the Superintendent for the suspension without pay and termination of employment of Elaine Murphy. The hearing is being held in accordance with School Board Policy 6.52 and Florida Statutes 1012.33, 120.569, and 120.57.

A Court Reporter will transcribe the proceedings and administer the oath to all persons testifying as witnesses. The Superintendent has the burden of proof and will present his case and witnesses first. The parties will be provided an opportunity to make an opening statement limited to not more than five (5) minutes each; and, at the conclusion of all the evidence, the parties will be provided an opportunity to make closing statements limited to not more than 10 minutes each.

Once the presentations have been completed, the School Board members will deliberate and rule on the recommendation from the Superintendent.

The School Board's Attorney will explain to the School Board members and answer issues and questions of procedure as these questions arise during the course of the hearing.

It is the recommendation of the Superintendent that Elaine Murphy be suspended without pay effective April 24, 2014, through May 13, 2014, and that employment of Elaine Murphy be terminated effective May 14, 2014.



RECOMMENDATION:


That the Board revise the method of selecting and recognizing top students at graduation to include the following:

- Based upon the weighted GPA, the top 1% of students in the graduating class be designated Summa Cum Laude, the next 2% designated Magna Cum Laude, and the next 2% designated Cum Laude.
- Calculate the ranking at the end of the first semester of the graduating year.
- The weighted grade point average will be calculated using all courses taken regardless of location taken.
- In order to be considered for graduation recognition, a student must be enrolled prior to the beginning of the senior year unless the family's relocation to Okeechobee during the first semester of the senior year was due to military circumstances.
- Dual Enrollment and Advanced Placement courses will have a weighting of 6.0.
- Honors and Level 3 courses will have a weighting of 5.0.
- Students who will meet the requirements for a standard diploma will be considered for recognition.
- The calculation shall be carried out to four (4) decimal places.
- Weighted GPA will be used to determine rank in the student database. Rank will be used to determine graduation recognition.

BACKGROUND INFORMATION:

The School Board directed the Superintendent to recommend changes to the current system of recognition at graduation exercises. If approved these changes will be included in the 2014-15 Student Progression Plan.



Re: Summer Work Schedule

An agreement has been reached between the Okeechobee County Education Association ("the OCEA") and the School Board of Okeechobee County ("the Board") regarding the summer work schedule for July, 2014, as follows:

July 7 – July 24: 7:30 a.m. - 5:30 p.m. (Monday through Thursday)

All offices will be closed Fridays: July 4, 11, 18, 25


There will, however, be one departmental exception to the above. Due to the state requirement that public schools provide food services to summer recreational programs, members of the Food Service staff may be employed 4.5 to 6 hours/day, 5 days/week, with 4 to 5.5 hours/day paid and a 30 minute unpaid lunch, during the month of July. One paid 15-minute break shall be provided to these employees each day.

Other categories of classified and instructional employees shall work the 4-day summer work schedule as follows:


- 8-hour classified employees who normally receive a 1-hour or 30-minute unpaid lunch period during the regular 5-day work schedule shall work 9 hours per day with an hour for lunch. Thirty (30) minutes of paid break time shall be provided to these employees during their 9-hour summer workday. (Employees will work a total of 9 hours spread over 10 clock hours.)
- 7.5-hour instructional employees who normally receive a 30-minute paid lunch period during the regular 5-day work schedule shall work 8 hours per day with an hour for lunch. (Employees will work a total of 8 hours spread over 9 clock hours.)
- 7.5-hour classified employees who normally receive a 30-minute unpaid lunch period during the regular 5-day work week shall work 8 hours 30 minutes per day with an hour for lunch. Thirty (30) minutes of paid break time shall be provided to these employees during their work day. (Employees will work a total of 8.5 hours spread over 9.5 hours.)

Staff will return to the normal work schedule on Monday, July 28, 2014.



**MEMORANDUM OF AGREEMENT  
BETWEEN THE SCHOOL DISTRICT OF VOLUSIA COUNTY  
AND THE SCHOOL DISTRICT OF OKEECHOBEE COUNTY  
FOR END OF COURSE ASSESSMENT COOPERATION**

This *Memorandum of Agreement Between the School District of Volusia County and the School District of Okeechobee County for End of Course Assessment Cooperation* (“Agreement”) is made between the School District of Volusia County (“Volusia”) and the School District of Okeechobee County (“Okeechobee”) and provides as follows:

**RECITALS**

Whereas, Florida school districts are required to develop local assessments for each course offered in the district beginning in the 2014-2015 school year pursuant to section 1008.22(8), Florida Statutes (2013);

Whereas, representatives of 39 Florida school districts commenced a collaborative effort in 2011 as part of a group referred to as the Central Florida Assessment Collaborative (“CFAC”) to comply with this requirement with the goal of developing district end of course assessments for courses not subject to federal and state Race to the Top grant requirements (“Project”);

Whereas, the Project, and this Agreement, do not relate to the development of end of course assessments for courses subject to federal and state Race To The Top grant requirements;

Whereas, Okeechobee has determined that it is unable to secure sufficient human resources to contribute their fair share to the Project and seeks to, alternatively, contribute financial resources;

Whereas, the School District of Osceola County and the School District of Volusia County have entered into a memorandum of understanding to assist CFAC in working with Okeechobee and other participating school districts in coordinating some aspects of the Project;

Whereas, these recitals shall be incorporated into this Agreement as if fully set forth below; and

Whereas, Okeechobee agrees to participate in the Project the amounts, and on behalf of school districts, specified in this Agreement.

1. Term. This Agreement shall take effect immediately upon execution by both parties and expire on June 30, 2015.

2. Fee schedule. The fee structure to be paid by Okeechobee is based on the following structure from the Race to the Top District Developed Assessments grant application. Item writers will be compensated \$30 dollars for each accepted item, while item reviewers will be compensated \$6 dollars for each reviewed item. Item writers and reviewers will also be compensated \$50 dollars for completion of the online training. Finally, should the need arise, test item specification developers will be compensated \$1,000 dollars per subject area for which they develop test item specifications and test blueprints. The cost is based on the school district's size and enrollment, percentage of work that will be required and the total number of items written and items reviewed that would be needed from each school district. The total amount that would be invoiced for Okeechobee is \$2,534.25 based on the following:

Each participating district's minimum number of items required to be written and reviewed is proportional to the district size and resources. Any unused pre-paid funds collected will be equitably allocated back to each participating school district after all costs have been accounted for no later than December 31, 2014. Okeechobee agrees to become a collaborative member with other districts as part of the CFAC to develop high-quality assessment item banks for identified "gap" courses. Volusia will invoice Okeechobee for the above amount in order to develop the needed non-core curriculum assessments. This fee schedule is based on the best estimate of time and resources required to prepare these assessments. In the event that it is determined that said fees are not sufficient, Okeechobee will be notified and informed of additional fees that will be reasonably required to continue participation in the Project.

3. Deadline. Okeechobee must remit payment in accordance with this Agreement to Volusia by no later than June 2, 2014.
4. Sovereign Immunity. The parties retain and reserve all rights, privileges, immunities and benefits of sovereign immunity.
5. Hold harmless. The role of Volusia under this Agreement is limited to processing payments to individuals that perform services for this Project at the direction of CFAC and Okeechobee shall hold Volusia harmless for any and all aspects of the Project.
6. Complete Agreement. This Agreement constitutes the entire and complete agreement between the parties.

7. Third party beneficiaries. Nothing in this Agreement shall be relied upon by any third party or be interpreted to create a cause of action by any third party.

**Purpose, Terms and Conditions**

This Contractual Service Agreement serves as a written understanding between each member of the Research Coast Career Pathways Consortium (RCCPC), consisting of Indian River State College, Indian River County School District, Martin County School District, Okeechobee County School District, and Saint Lucie County School District to the terms and conditions set forth herein pursuant to the Florida Department of Education Carl D. Perkins Career and Technical Education Programs Grant Application - Section 131 and/or 132 and in compliance with Florida Statutes, Section 215.422, 216.347, 216.3475, Rule 60A-1.017, Florida Administrative Code.

The Research Coast Career Pathways Consortium was established for the local, state, and national implementation of Career Pathways and Career and Technical Education.

Indian River State College will develop accounts to manage the transfer of funds from the consortium partners' secondary Perkins grants and will serve as fiscal agent of the Research Coast Career Pathways Consortium.

**Target Population**

The Research Coast Career Pathways Consortium agrees to provide support for Career and Technical Education educators, administrators, career and academic guidance counselors, and Career and Technical Education students to ensure the provision of optimal programmatic implementation for the consortium's fourteen area high schools.

**Scope of Work**

The partners of the Research Coast Career Pathways Consortium agree to jointly implement the goals and objectives for the fiscal year 2014 - 2015. Funds, in the amount of \$1,166 or 1.5% of the Okeechobee County Consortium partner total basic Perkins grant fund, shall be used to support eligible Career and Technical Education programs and initiatives including the following minimum requirements: (Please note that the balance of funds is inclusive of and contingent upon the release of the total funds from the aforementioned consortium partner. See Exhibit 1 for details.)

- The consortium's activities will provide professional development and in-service opportunities for teachers, counselors, and administrators for the advancement of Career & Technical Education. The consortium will continually develop new inter-disciplinary strategies for Academic and Career & Technical Education teachers in order to provide quality

- programs for our Career and Technical Education students.
- Development of new resources for students, parents, and the community to access information about Career and Technical Education and Career Pathways, what our local area offers for Career and Technical Education Students, and additional resources.
  - The consortium will continue curriculum alignment and articulation activities for our 29,000+ students in the high schools of Indian River, Martin, Okeechobee, and St. Lucie Counties during the period of July 1, 2014 through June 30, 2015. The Consortium partners will convene a minimum of six times during the 2014-2015 fiscal year to ensure alignment of secondary and postsecondary Career and Technical Education curricula.
  - Data analysis and tracking reports will assist program directors and advisors with student recruitment and retention.

Documentation of tasks and services will be provided through the following:

- Minutes of monthly Consortium meetings,
- Articulation agreements generated annually,
- Articulated credit matrix report /Program of Study, and
- College records of students receiving Career Pathways College Credit
- Documentation of professional development and in-service opportunities for consortium partners including agendas and attendance rosters.

The school district research coast career pathways consortium members reserve the right to withhold a portion of the 1.5% Perkins allocation funds for transportation cost associated with participating in the annual Indian River State College Great Exploration event. The funding portion reserved will not exceed standard school district(s) transportation rates.

The scope of work is directly related to the secondary and postsecondary goals of Perkins IV, Section 134 (B)(3).

**Deliverables and Performance Standards**

Fiscal Agent, Indian River State College, and the RCCPC will maintain, review, update, implement, and report no less than 3 Programs of Study per county for the 2014 -2015 fiscal year, for Career Pathways and Career and Technical Education students transitioning from the consortium's secondary programs to IRSC. All Articulation Agreements will be written and reviewed by the RCCPC, and signed by Indian River State College and the

County School Districts. The signed agreements will serve as documentation that the consortium's goals and objectives and agreements for articulation have been met. Reports of all articulation agreements and activities will be made available upon request.
