



RECOMMENDATION:

That the Board approve a Transition to Teaching (T2T) Agreement with Indian River State College.

BACKGROUND INFORMATION:

This is a new agreement that permits the placement of highly qualified teacher candidates from IRSC's School of Education programs into District classrooms as the teacher of record. Teacher interns will be assigned a mentor teacher at their school as well as being provided guidance by their University Supervisor and a Transition to Teaching coach. The District will pay one-half of a beginning teacher's annual salary including benefits per semester. The agreement is attached.

**Transition to Teaching (T2T)**  
**School Agreement**  
**2014-2015**

(SCHOOL NAME), located in the Okeechobee County School District, agrees to permit the placement of qualified teacher candidates through the Intensive Transition to Teaching at Indian River State College, which places highly-qualified teacher candidates into classrooms as the teacher of record and provides them the support they need to be highly effective.

Qualified individuals will be selected from IRSC's School of Education programs. Those selected will possess a distinct set of skills shown by research to be possessed by effective teachers and will have passed through a thorough screening process in order to be considered.

Students who take part in IRSC's Transition to Teaching (T2T) will be assigned a mentor teacher at their school and will be provided with additional guidance by their University Supervisor and Transition to Teaching (T2T) coach. These individuals will provide the intern with guidance throughout the entire student teaching period. In addition, the intern will be required to participate in a weekly student teaching seminar at IRSC.

The Transition to Teaching (T2T) coach will continuously provide comprehensive guidance throughout the term and will observe the intern and provide feedback according to the following schedule:

- Daily for the first five weeks (3 hours/day)
- Three times a week for the next four weeks (2 hours/day)
- Twice a week for the next three weeks (1 hour/day)
- As needed for the remainder of the school district's semester

Additional weeks beyond the initial twelve (indicated in the first three bullets above) may be added to the supervised portion of the internship, if the student is assessed as needing additional assistance. In such cases, those decisions will be made by a committee consisting of: IRSC's Clinical Experience Coordinator, the University Supervisor, Transition to Teaching (T2T) coach and on-site mentor teacher. A plan will be drawn up detailing specific items needing additional work. If the student has successfully completed the initial twelve weeks, under close supervision, he/she is considered as having completed student teaching.

As part of this agreement, the school district shall pay one-half of a beginning teacher's annual salary (including benefits) per semester for each intern placed as part of this program, including compensation for paid holidays and teacher training days as outlined below:

- Half a year of the school district's beginning teacher salary (including benefits) \$23,984.28
- Stipend paid to the intern by the school district (\$6,000.00)
- Balance made payable to IRSC in support of the coach's wages \$17,984.28

Payment to IRSC will be made at the halfway (six-week) mark of the internship and payment to the intern will be made at the end of the semester.

Upon successful completion of the program, there is an expectation by IRSC and the teacher candidate that the student will be offered a teaching position by the district.
