The Okeechobee County School Board met in regular session on the above date with the following members present: Chairman David Williams, Vice Chairman India Riedel, Joe Arnold; Gay Carlton; and Malissa Morgan. Also present were Ken Kenworthy, Superintendent of Schools, and Tom Conely, School Board Attorney.

Chairman Williams called the meeting to order. Rev. Dr. Edward Weiss, Church of Our Savior, opened the meeting with prayer, and Chairman Williams led those present in the pledge of allegiance.

The Board and Superintendent recognized Mrs. Betty Williamson for her long-standing support of education, and most recently, her gift to the Retired Educators' *Hooked on Books* program which benefits District students by placing donated books in school libraries. Superintendent Kenworthy commented that Mrs. Williamson requested that instead of giving her presents for her most recent birthday, that friends bring a book to her birthday party for donation to the *Hooked on Books* program. Gay Carlton, School Board Member and President of the Okeechobee County Retired Educators' Association, mentioned that to date the number of books donated to schools by the *Hooked on Books* program totals 350.

The Board and Superintendent recognized the Kiwanis Club for receiving a Commissioner's Business Recognition Award, which was presented recently in Tampa by Florida's Education Commissioner Dr. Tony Bennett. J.D. Mixon, Kiwanis Club President, and Ken Keller, Kiwanis Club Vice President, were present at the Board meeting to receive a Certificate of Appreciation. Superintendent Kenworthy thanked the Kiwanis Club for the numerous ways that they partner with District schools and students such as sponsoring scholarships, mini-grants for teachers, providing school supplies, providing food and gifts for youth enrolled in local DJJ programs, and for stepping up to the plate to continue the Grad Night party. Mr. Mixon added a thank you to the Children's Services Council for assisting in funding Grad Night.

The Board and Superintendent recognized Bill Huddle, Building Code Administrator for his retirement after 11 years of service to the District. Superintendent Kenworthy commented that the excellent condition of the District's facilities is due in part to Mr. Huddle's expertise in the building industry. Mr. Huddle commented that he has worked in the District as a Building Code Inspector for 18 years, 11 of which were as an employee of the Board.

A presentation was made to the Board by Renée Geeting, Director of Student Services, regarding the Common Core State Standards which are replacing the Sunshine State Standards. Highlights of the presentation included:

- The Common Core State Standards guide the development of curricula that promotes a deeper understanding for academic concepts and process for all students.
- Twenty-five years ago, 95% of jobs required low level skills, and today low-level skills jobs constitute only 10% of the country's entire economy. In the years 1997 to 2002, there was as much information generated as in the entire history of the world. There is now so much information available and at hand, that it would be impossible to learn everything.
- Nationwide, there is concern about the growing number of college students in need of remedial courses and the growing skills gap in the workforce. One main goal of the Common Core State Standards is for high school students to transition to postsecondary education and/or careers without remedial or intermediate coursework.
- The Common Core State Standards seek to increase a student's ability to look at different texts, glean information from those texts, and form his/her own opinion about the information. Common Cores State Standards provide a consistent, clear understanding of what students are expected to learn. Common Core State Standards is a State led initiative with local control surrounding curriculum and instruction decisions. The Standards are for Mathematics, English/Language Arts, and Literacy.
- Florida Education Commissioner Dr. Tony Bennett was recently quoted as saying that the move to the Common Core State Standards will "transform the way students learn, teachers teach, and how we assess those two activities." We are "transforming student learning through the transformation of teaching."

- "Rigor" is mentioned quite frequently in the Common Core State Standards. Rigor is not something extra added on top of everything else. Rigor is found in activities and planned by teachers to engage students in higher order thinking.
- The Common Core State Standards embrace the idea that literacy is everyone's responsibility. It seeks to teach students how to read informational texts across content areas and be able to connect and use the information.
- The Common Core State Standards are fewer, clearer, higher, and are aligned with college and career expectations and standards. They include rigorous content and application of knowledge through higher order skills. The Common Core State Standards are consistent across all participating states.
- Phase 1 (2011-12) Common Core State Standards were implemented in Kindergarten. The implementation of the Literacy Standards began in Grades 6-12, as well as the Rich and Complex Text and Informational Text Standards for Grades K-12.
- Phase 2 (2012-13) –Full implementation of the Common Core State Standards in Grades K-1 occurred, as well as full implementation of Literacy Standards in all content areas for Grades 6-12. Also, implementation continued for Rich and Complex Text and Informational Text for Grades K-12.
- Phase 3 (2013-14) Full implementation of the Standards for Grades K-2, implementation of a Blended Curriculum for Grades 3-12, and continuation of Rich and Complex Text and Informational Text for Grades K-12 will occur.
- Phase 4 (2014-15) Full implementation of the Common Core State Standards for Grades K-12 and alignment of PARCC Assessments to Common Core State Standards will occur.
- Moving forward, the Common Core State Standards will allow for more focused professional development for teachers. The focus must be on classroom teachers having the time, tools, and support to make the Standards come alive in the classroom.

Board Member Joe Arnold asked if parents can opt out of the Common Core State Standards. Superintendent Kenworthy responded that opting out is not possible if attending public school in Florida, since the Common Core State Standards have been adopted by the State. Mr. Arnold asked what will happen if parents do not want their student(s) to take an online, standardized assessment. Superintendent Kenworthy responded that there really is not an opt-out available for online testing. The parent could keep the child home that day, although it would hurt the school in terms of their school grade. Superintendent Kenworthy went on to say that he understands the privacy concerns that some parents may have, but it is not possible in this day and age to provide the same level of education without the use of technology. Mr. Arnold stated that he has a number of concerns about Common Core State Standards and online testing. He said that his concerns are that a huge data base is being built that will cause privacy issues for students in the future, that Common Core State Standards will remove the voice of local education, that federal dollars are being used to pay for the PARCC online testing, that there are no science lab requirements for the Common Core Standards, that vocational education will be lost over time, and that the Common Core State Standards are sub-par to standards the District has been using. Superintendent Kenworthy responded that right now, this is the plan laid out for Florida's education system and that the School Board has no authority to not implement the Common Core State Standards. He also stated that the education system must get away from thinking that using the textbook is the only way to teach. In response to concerns about losing science labs, graduation still requires three science credits, two of which must be in lab courses.

Board Member Malissa Morgan stated that local control is not lost since districts choose the curriculum they want to use to achieve the standards. She also stated that she likes the literacy piece of the Common Core State Standards. Vice Chairman India Riedel stated that she is actually excited about having standards that are less in number so that it is easier to guide students in the right direction. Also, the use and teaching of technology is important as individuals who can think on their feet with technology are in high demand. Ms. Riedel said that she will continue to push for vocational education and that the Board should keep in mind some of Mr. Arnold's concerns while moving forward with implementation of the Common Core Standards.

On a motion by Joe Arnold, seconded by India Riedel, the Board voted unanimously to approve the Minutes of the regular meeting held on June 11, 2013.

On a motion by Joe Arnold, seconded by Malissa Morgan, the Board voted unanimously to approve the Minutes of the Legislative Hearing held on June 12, 2013.

On a motion by Joe Arnold, seconded by Gay Carlton, the Board voted unanimously to approve the Minutes of the special meeting held on June 21, 2013.

Chairman Williams asked if there were any requests from the Board or Superintendent for changes, additions, or deletions to the *Items for Action*. There were no requests.

On the recommendation of Superintendent Kenworthy and a motion by Gay Carlton, seconded by Joe Arnold, the Board voted unanimously to approve advertisement to amend Board Policy 5.40 <u>Student</u> <u>Control</u> (*Code of Student Conduct*). Superintendent Kenworthy reviewed changes to the Code as follows:

- Addition of new language regarding bullying and harassment as it currently appears in Board Policy 5.321 <u>Bullying and Harassment</u>
- Addition of language regarding recent legislative changes in cyber-bullying to include bullying or harassment through access on both school and non-school locations regardless of the owner of the computer, system, or network
- Addition to Section K. Tobacco: Possession and/or Use and Dispensing to include Electronic Cigarettes as required by SESIR (School Environmental Safety Incident Reporting)
- Revision of wording regarding modifications of the Code for students with active Individual Education Plans and Section 504 modification plans
- Formatting/Grammatical Changes

The School Board of Okeechobee County, Florida, hereby certifies that pursuant to a legal notice, a meeting for public hearing was held in Room 303 of the School Board Administrative Office, 700 S.W. 2nd Avenue, at 6:00 p.m. in the City of Okeechobee on the 9th day of July, 2013, for the purpose of discussing adoption of Board Policy 4.22 <u>Academic Acceleration</u> and Board Policy 4.24 <u>Early High School</u> <u>Graduation</u>. The Board further certifies that it remained in session until 7:20 p.m. and that there appeared no one at said hearing to oppose or discuss these policy adoptions.

On the recommendation of Superintendent Kenworthy and a motion by Joe Arnold, seconded by India Riedel, the Board voted unanimously to approve adoption of Board Policy 4.22 <u>Academic Acceleration</u> to implement F.S. 1002.3105, *Academically Challenging Curriculum to Enhance Learning*. Superintendent Kenworthy stated that the proposed Policy 4.22 outlines student opportunities to participate in accelerated learning. Advertisement of intent to adopt Policy 4.22 was approved by the School Board on June 11, 2013, and legally advertised to the public on June 12, 2013, as required by Chapter 120, Administrative Procedures Act, Florida Statutes.

On the recommendation of Superintendent Kenworthy and a motion by Joe Arnold, seconded by Malissa Morgan, the Board voted unanimously to approve adoption of Board Policy 4.24 <u>Early High School</u> <u>Graduation</u> to implement 1003.4281, *Early High School Graduation*. Superintendent Kenworthy stated that the proposed Policy 4.24 permits election of early graduation for those students who have earned twenty-four (24) credits and meet graduation requirements in accordance with Florida Statutes. Advertisement of intent to adopt Policy 4.24 was approved by the School Board on June 11, 2013, and legally advertised to the public on June 12, 2013, as required by Chapter 120, Administrative Procedures Act, Florida Statutes. Malissa Arnold asked if students who elect early graduation will be permitted to walk with their class at commencement, and Superintendent Kenworthy responded that they would be allowed to walk with their class if they choose to.

On the recommendation of Superintendent Kenworthy and a motion by India Riedel, seconded by Joe Arnold, the Board voted unanimously to approve the starting and dismissal times for students for the 2013-14 school year as follows:

Superintendent Kenworthy commented that there is a change to Okeechobee High School starting and ending times. The starting time is being changed from 7:08 a.m. to 7:00 a.m., and the ending time is being changed from 2:05 p.m. to 2:10 p.m. This will extend the instructional day at OHS so that the first semester can be completed prior to the winter break.

Superintendent Kenworthy recommended that the Board set a date, time, and location for conducting a legislative hearing to resolve items at impasse for the Instructional Personnel Contract. Joe Arnold asked for the first available date that would allow the required advertisement. Superintendent Kenworthy responded that the first available date would be Friday, July 19. Tom Bonasera, President of Okeechobee County Education Association #1604 (OCEA), stated that OCEA could not attend a legislative hearing before August 13, in order to allow time for their staff to return back to school. Vice Chairman India Riedel stated that she wants to resolve last year's contract issues before the beginning of school so that the District can move forward with 2013-14 bargaining. Board Member Malissa Morgan asked Mr. Bonasera if he could get the OCEA bargaining team together before August 13, and Mr. Bonasera responded that he could not. He stated that the OCEA staff are volunteers and are not at work this time of year and may not be in the area. Vice Chairman Riedel asked if he could contact his staff by email or cell phone to make arrangements for them to be present at an earlier date, and Mr. Bonasera responded that he could not. Board Member Gay Carlton suggested that OCEA's representatives who want to address the Board at the legislative hearing could do so by letter or phone call. Mr. Bonasera stated that OCEA prefers that their witnesses be physically present at the hearing. Superintendent Kenworthy reminded the Board that Florida Statute specifies that the legislative hearing must be held "forthwith," meaning immediately. Vice Chairman Riedel expressed concerns about the Board being in violation of statute if they wait any longer for a legislative hearing. She stated that she prefers that the legislative hearing be held as soon as possible. Mr. Bonasera reiterated that OCEA was not available before August 13. The Board looked to Mr. Conely, School Board Attorney, for guidance. Mr. Conely advised the Board that the legislative hearing is the Board's hearing and that the parties must comply with the Board's decision on dates. After further discussion of the Board regarding dates for a hearing, Joe Arnold made a motion that the recommendation be tabled and taken up at the July 23rd School Board meeting. The motion was seconded by Gay Carlton, and the Board voted unanimously to table the recommendation until their meeting on July 23, 2013.

On the recommendation of Superintendent Kenworthy and a motion by India Riedel, seconded by Gay Carlton, the Board voted unanimously to appoint Renée Geeting as Assistant Superintendent for Instructional Services effective July 1, 2013, for the 2013-14 fiscal year.
