IX. Information Items

A. SUPERINTENDENT

- Superintendent Kenworthy shared the Heartland Educational Consortium Legislative Issues for 2015 with the Board.
- Superintendent Kenworthy told the Board that the Transportation Department is investigating the possibility of adding transportation services for students staying after school for tutorial programs. The service would begin at 5:00 p.m., and the routes would be fixed routes with possibly one or two stops per neighborhood. Superintendent Kenworthy commented that lack of transportation is one barrier to children staying after school to take advantage of tutorial services that are offered.
- The District is looking at expanding summer program offerings significantly this year with elementary and middle school level programs. This will address the summer loss in academics. Superintendent Kenworthy reported that bus transportation will operate at fixed stops in communities.
- Superintendent Kenworthy invited the Board to attend the Teacher/School-Related Employee of the Year banquet at 7:00 p.m. on Friday, February 13, 2015, at the KOA Convention Center.
- Superintendent Kenworthy asked the Board for feedback regarding tobacco free schools. He said that he has once again been contacted by the Health Department to make all school properties tobacco free. Chairman Joe Arnold asked the Superintendent if any surveys of parents, students, or employees have been conducted. Superintendent Kenworthy responded that no surveys have as yet been done, but that it would be possible to do so if it the Board wants to go in that direction. Member Jill Holcomb asked if Palm Beach, Martin, St. Lucie, and Indian River Counties are smoke free schools. Superintendent Kenworthy responded that although these counties do have smoke free policies, the enforcement of the policies varies. Member India Riedel agreed that surveying parents would be a good idea before moving forward. Chairman Arnold asked if instituting a smoke free policy would need to be negotiated with the Okeechobee County Education Association, and Superintendent Kenworthy responded that it would have to be impact bargained since it affects conditions of employment. Chairman Arnold stated that when employees are hired, there was some expectation of rights, and that those rights

should stay with those employees rather than taking their rights away. Vice Chair Malissa Morgan stated that she believes the Board should have input from the community and parents and then workshop the issue before coming to a decision. The other Board members were in agreement. Superintendent Kenworthy stated that he will gather information for the Board for the February $10^{\rm th}$, and Member India Riedel suggested the that the Board decide at the February meeting if they would like to workshop the issue.

• Superintendent Kenworthy asked the Board if they are interested in participating in the Master Board Certification program offered by the Florida School Boards Association. The program would require the Board members and Superintendent to participate in one offsite training and three onsite training sessions. The cost for the certification training is \$4,500.00. Chairman Arnold commented that the training would be beneficial for the Board, especially since there are now new members who have not participated in the last certification process. Board members expressed agreement with Chairman Arnold as well as concern for the expenditure of \$4,500.00 at this time. After further discussion, the Board requested that the Superintendent provide information about the schedule for the trainings and place an action item on the February 10th agenda for Board consideration.

B. SCHOOL BOARD MEMBERS

- Chairman Arnold stated that the court had dropped part of the lawsuit filed by the Florida School Boards Association against the Florida Congress, and it appears that the court will dismiss the remainder of the suit. Chairman Arnold said that he would like the Board to move forward in adopting a resolution, as several other districts have done, stating the Board's position on accountability and asking the State to decrease the number of student assessments required during the year. Two districts mentioned by Chairman Arnold as having adopted resolutions are Palm Beach County and Levy County. Chairman Arnold stated that he believes the overabundance of testing is overwhelming teachers and students. Vice Chair Malissa Morgan agreed that a resolution is needed and that there is too much pressure on students and teachers. She added that the product that educators are producing is not the product that they want. Member Jill Holcomb stated that Citrus County's resolution included a request that School Grades be delayed for one year. Superintendent Kenworthy will bring the Board a resolution at their February 10th meeting for consideration.
- Vice Chair Malissa Morgan thanked Superintendent Kenworthy for arranging quarterly Board visits to schools. She commented that on the visits the Board gets to see great things happening in classrooms.
