# **Amendment of Board Policy 3.33 Prohibition of Harassment**

- I. This policy prohibits harassment of employees and students.
- II. The proposed amendment updates protected classes as required by revision to the Florida Civil Rights Act.
- III. Legal authority for this policy is F.S. 120.54, 1001.41,1001.42, 1012.23. Laws implemented are F.S. 112.51, 119.07, 760.01 et seq., 1000.05, 1000.21, 1001.43, 1012.22; 34 CFR 99, 34 CFR 200.43(c), P.L. 110-223.
- IV. This policy amendment will not affect individuals from an economic standpoint.

#### **Amendment of Board Policy 3.48 Service Animals**

- I. This policy defines the tasks of service dogs allowable on school campuses.
- II. The proposed amendment updates the tasks and control of service animals to be consistent with revisions to FS 413.08.
- III. Legal authority for this policy is F.S. 100.41, 1001.42. Laws implemented are F.S. 413.08, 1001.32, 1001.43, 1006.07, 1006.08; 28 CFR 35.104, 28 CFR 35.136, 28 CFR 36.104, 34 CFR 104.
- IV. This policy amendment will not affect individuals from an economic standpoint.

### **Amendment of Board Policy 4.60 District Assessment Program**

- I. This policy outlines general requirements of the District Assessment Program.
- II. The proposed amendment updates the policy to coincide with HB 7069.
- III. Legal authority for this policy is F.S. 100.41, 1001.42. Laws implemented are F.S. 1000.21, 1001.11(5), 1001.43, 1008.22, 1008.34.
- IV. This policy amendment will not affect individuals from an economic standpoint.

## **Amendment of Board Policy 6.15 Paraprofessionals**

- I. This policy outlines employment requirements and duties of paraprofessionals.
- II. The proposed amendment brings the policy into agreement with revisions to HB 7069.
- III. Legal authority for this policy is F.S. 100.41, 1012.22, 1012.23. Laws implemented are F.S. 1001.43, 1008.24, 1012.22, 1012.32, 1012.37; 34 CFR 200.
- IV. This policy amendment will not affect individuals from an economic standpoint.

#### **Amendment of Board Policy 7.65 Antifraud**

- I. This policy defines fraud and the consequences for committing fraud.
- II. The proposed amendment suggested by the Auditor General's staff addresses false or incorrect reporting of fraud.
- III. Legal authority for this policy is F.S. 1001.32, 1001.41, 1001.42. Laws implemented are F.S. 1001.42, 1001.43.
- IV. This policy amendment will not affect individuals from an economic standpoint.

## **Adoption of Board Policy 5.55 Notification of Involuntary Examination**

- I. This policy provides guidelines for immediate parent notification when a student is taken for an involuntary examination.
- II. The proposed policy is required by statute to address parent notification.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are F.S. 381.0056, 394.463, 1001.21, 1002.20, 1006.062.
- IV. This policy amendment will not affect individuals from an economic standpoint.
