RESOLUTION # 17-005

A RESOLUTION REGARDING A LEASE PURCHASE AGREEMENT FOR THE PURPOSE OF FINANCING "LITERACY SOFTWARE PROGRAM".

WHEREAS, the Okeechobee County School District desires to enter into that certain Financing Agreement, by and between Government Capital Corporation and Okeechobee County School District, for the purpose of financing "Literacy Software Program". The Okeechobee County School District desires to designate this Agreement as a "qualified tax exempt obligation" of the Okeechobee County School District for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended. The Okeechobee County School District desires to designate Ken Kenworthy, who's title is Superintendent, as an authorized signer of the Agreement.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF THE OKEECHOBEE COUNTY SCHOOL DISTRICT:

<u>Section 1.</u> That the Okeechobee County School District enters into a Financing Agreement with Government Capital Corporation for the purpose of financing "*Literacy Software Program*".

<u>Section 2.</u> That the Financing Agreement, by and between the Okeechobee County School District and Government Capital Corporation is designated by the Okeechobee County School District as a "qualified tax exempt obligation" for the purposes of Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended.

<u>Section 3.</u> That the Okeechobee County School District designates Ken Kenworthy, who's title is Superintendent, as an authorized signer of the Financing Agreement, by and between the Okeechobee County School District and Government Capital Corporation.
