PROCLAIMING MAY 2020, MENTAL HEALTH AWARENESS MONTH IN OKEECHOBEE, FLORIDA

WHEREAS, good mental health is a key component in a child's healthy development and Children's Mental Health Week provides the opportunity to focus on this important matter, while celebrating the accomplishments of children and families affected by mental health concerns; and

WHEREAS, it is important that youth, their families, and communities learn about warning signs of mental health disorders and where to obtain necessary assistance and services; and WHEREAS, open dialogue is an essential component to fight stigma and encourage those who might benefit from services to seek help; and

WHEREAS, there is a need for access to comprehensive services that are family-driven, youth guided, culturally and linguistically competent, and community based; they also benefit from the integration of behavioral health in primary care, education, and child welfare; and

WHEREAS, it is appropriate that week (May $1^{st} - 7^{th}$) and specifically a day (May 7th) should be set apart each year to recognize the importance of our children's mental health and well-being and our responsibility to promote them; and

WHEREAS, all citizens, agencies, and organizations interested in advancing innovative strategies addressing children's behavioral health including suicide prevention can unite to promote effective services;

WHEREAS, promoting mental health and wellness leads to higher overall productivity, better educational outcomes, lower crime rates, stronger economies, lower health care costs, improved family life, improved quality of life and increased lifespan, and;

WHEREAS, studies show that the effects of ACEs are felt by people regardless of race, ethnicity, religion, gender, sexual orientation, or socio-economic status, and;

WHEREAS, each business, school, government agency, healthcare provider, faith-based organization, non-profit agency and resident shares accountability for the community's mental health needs and has a responsibility to promote mental wellness and support prevention efforts, and;

WHEREAS, Okeechobee County, recognizes the impact of awareness and education, access to services, and acceptance of the importance of mental health and well-being to a person's overall success and supports the implementation of trauma informed approaches throughout the systems of care.

NOW, THEREFORE, BE IT PROCLAIMED BY THE Okeechobee County School Board in OKEECHOBEE, FLORIDA, that May 2020, is hereby proclaimed as:

MENTAL HEALTH AWARENESS MONTH.

2.201

EMERGENCY POLICY RELATING TO SCHOOL BOARD MEETINGS

POLICY

- I. **Purpose**. The Board recognizes the need during this health emergency posed by the spread of COVID-19 to hold virtual or telephonic meetings as set forth in the March 17, 2020 Florida Department of Education's Additional Guidance for the 2019-2020 School Year, and for reasons allowed by Executive Order Number 20-69, DOE directive, Attorney General Opinion, or Florida Law (hereinafter referred to as "Directives").
- II. **Emergency Meetings During This Time.** This Policy modifies and supersedes School Board Policy 2.20 on Board meetings. This Policy is consistent with the directives to address items during this time and hold virtual or telephonic meetings where a quorum of Board members is not required to be physically present at the meeting in order to conduct and vote upon business. These meetings must be accessible to interested members of the public who wish to attend.
- III. **Public Comment**. In addition, this Policy modifies certain provisions in Policy 2.20 relating to public comment and allows public comment on agenda items through an online platform. The Meeting Notice shall state:
 - A. how interested persons can attend virtually, and
 - B. the method for public comments to be heard.
- IV. **Authority.** This policy supersedes any other policy and Policy 2.20 that is not consistent with the language herein relating to these emergency Board meetings.
- V. **Duration of Policy**. This policy becomes effective upon its emergency adoption. This policy shall remain in force as long as permissible while under the Governor's Executive Order regarding COVID-19.
