PARENT PREPARATION FOR A SUCCESSFUL SCHOOL YEAR

The following items will help keep you up to date on school activities and ready to respond to the big and little crises your child may have.

CHAIN OF WHO TO CALL

- Who do I contact when I have a concern regarding my child or children?
- * First, start with the classroom teacher (call or email). if you are not satisfied;
- * Second, contact an administrator (the Assistant Principal). if you are not satisfied;
- * Third, contact the Principal. if you are not satisfied;
- * Last, contact Student Services, from there your call will be routed to the appropriate department.

Note: it is always better to start at the school site with communication; it will speed up getting to a solution!

SUCCESSFUL PARENT-TEACHER CONFERENCE

A good way to find out how your child is doing in school is through a parent-teacher conference. The teacher may request a conference or you may request a meeting. Listed are some tips for having a successful parent-teacher conference:

- Make a list of questions and concerns you have and write them down.
- Keep track of your child's schoolwork to help you with your questions.
- Listen to what the teacher has to say and ask questions if you do not understand what the teacher is trying to tell you.
- Schedule a follow-up appointment if necessary.
- Try to work with the teacher to help your child; teamwork is the best approach.

Here are some questions to keep in mind:

- Is my child performing at grade level?
 What are my child's strengths and weaknesses in reading, writing, mathematics, science, and social studies?
- How much time should my child be spending on homework?
- Are my child's assignments being completed correctly and on time?
- Do you have a folder of my child's work? Will you review it with me?
- Does my child get along with the other students?
- Does the school have special programs to meet my child's needs?
- What can I do at home to support what is happening in the classroom?
- What is the best way to keep in touch with you?

STUDENT RECORDS PRIVACY RIGHTS OF STUDENTS AND PARENTS

The Family Educational Rights and Privacy Act, 20 U.S.C. 1232g (FERPA), and corollary state law, Section 1002.22, Fla. Statute affords parents and students who have attained 18 years of age ("eligible students") certain rights with respect to the student's education records. These rights are:

The **right of privacy** with respect to the student's education records.

Personally identifiable records or reports of a student, and any personal information contained in those reports, are confidential. The Okeechobee County School Board will not release the education records of a student without the written consent of the eligible student or the student's parent(s) or guardian(s), except to the extent FERPA and state law authorized disclosure without consent.

The **right to inspect and review** the student's education record within 30 days of the day the District receives a request for access.

Parents or eligible students should submit to the school principal (or appropriate school official) a written request that identifies the record(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

The **right to request the amendment** of the student's education records that the parent or eligible student believes are inaccurate or misleading.

Parents or eligible students may ask Okeechobee County School District to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading.

If the District decides not to amend the record as requested by the parent or eligible student, the District will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

The **right to consent to disclosures** of personally identifiable information contained in the student's educational records, except to the extent that FERPA authorizes disclosure without consent.

One exception which permits disclosure without consent is disclosure to school officials with legitimate educational interests. A school official is a person employed by the District as an administrator, supervisor, instructor, or support staff member (including health person or medical staff and law enforcement unit personnel); a person serving on the School Board; a person or company with whom the District has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks.

A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

The Okeechobee County School District will forward educational and disciplinary records to other schools that have requested records and in which the student seeks or intends to enroll (34 CFR §§ 99.7 and 99.34(a)(1)(ii)).

Upon request, the District discloses education records without consent to officials of another school district in which a student seeks or intends to enroll.

The **right to file a complaint** with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA. The name and address of the office that administers FERPA is: Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, S.W., Washington, DC 20202-5920. Florida Statute, 1002.22, provides that an educational institution may, without authorization from parents, guardians, or eligible students, release "Directory Information". Directory information includes the following:

Student's name, address, telephone listing if not an unlisted number, date and place of birth, a major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, degrees and awards received, most recent educational institution attended by student, photographs in the school year book and similar information.

U.S. Code 20 U.S.C.S. 7908 requires local educational agencies (LEAs) to provide military recruiters with the name, address, and telephone listing of secondary student.

If any parent, guardian, or student above the age of 18 years objects to the release of such information, he/ she shall make known the objections, in writing, to the Superintendent by September 15th of the school year. The School Board shall release directory information after 30 days public notice has been given.

PROTECTION OF PUPIL RIGHTS AMENDMENT (PPRA) NOTICE

Pursuant to the Protection of Pupil Rights Amendment (PPRA) (20 USC §1232h; 34 CFR Part 98), parents, guardians, or eligible students (over the age of 18 or emancipated) have certain rights pertaining to surveys, the collection and use of information for marketing purposes, and certain physical exams. These rights are as follows:

1. The right to give prior written consent before students are required to submit to surveys concerning protected information (regarding political affiliation or beliefs; mental or psychological problems of the student or student's family, sex behavior or attitudes; illegal, antisocial, self-incriminating, or demeaning behavior; critical appraisal of others with whom survey respondents have close family relationships; legally recognized privileged relationships, such as with lawyers, doctors, or ministers; religious practices, affiliations, or beliefs of the student or parents; or income, other than as required by law to determine program eligibility) if the survey is funded in whole or in part by a program of the U.S. Department of Education.

2. The right to opt a student out of participation in any other protected information survey, regardless of funding.

3. The right to opt a student out of any non-emergency invasive physical exam or screening required as a condition of school attendance administered by the school or its agent, and not necessary to protect the immediate health and safety of a student. The right to opt out does not apply to hearing, vision, scoliosis or body mass index screenings, or any physical exam or screening permitted or required under State law, except on grounds of religious beliefs or physician certifications pursuant to F.S. 1003.22(5).

4. The right to opt a student out of activities involving the collection, disclosure, or use of personal information obtained from students for marketing or to sell or otherwise distribute the information to others, and

5. The right to inspect, upon request and prior to administration or use (a) protected information surveys of students, (b) instruments used to collect personal information from students for any marketing, sales, or distribution purposes, and (c) instructional material used as part of the educational curriculum.

The District will ensure that student privacy is protected in the administration of protected information surveys and the collection, disclosure, or use of personal information for marketing, sales, or other distribution purposes.

The District will directly notify parents of their PPRA rights at least annually at the start of each school year and after any substantive changes. The District will also directly notify (including, but not limited to, mail, e-mail, in-person, or by acknowledgement form) parents of students who are scheduled to participate in the specific activities or surveys noted above and will provide an opportunity for the parent to opt his or her child out of participation of the specific activity or survey. The District will make this notification to parents at the beginning of the school year if the District has identified the specific or approximate dates of the activities or surveys at that time. For surveys and activities scheduled after the school year starts, parents will be provided reasonable notification of the planned activities and surveys and will be provided an opportunity to opt their child out of such activities and surveys and to review any pertinent surveys.

Those who believe their rights have been violated may file a complaint with the Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, S.W., Washington, D.C. 20202. If you wish to discuss and try to resolve any PPRA concerns before contacting the Family Policy Compliance Office, you may contact the School Board of Okeechobee County, Director of Student Services (863) 462-5000 ext. 1060.

The Okeechobee Education Records Manual is set forth in District Manual 2.60, Student Education Records. The manual is available for inspection at the District Administration office located at 700 S.W. 2 Avenue, Okeechobee, Florida, during regular office hours Monday– Friday. A copy of the policy may be obtained free of charge, upon request.

Parental Rights in Education

The 2022 Florida Legislature passed House Bill 1557, Parental Rights in Education and the 2023 Florida Legislature updated this law through House Bill 1069. The bill outlines new responsibilities and considerations to include the following:

• A student's parent should be notified if there is a change in the student's services or monitoring related to the student's mental, emotional, or physical health or well-being and the school's ability to provide a safe and supportive learning environment for the student.

• Provides that school districts may not adopt procedures or student support forms that prohibit school district personnel from notifying a parent about his or her student's mental, emotional, or physical health or well-being, or a change in related services or monitoring, or that encourage or have the effect of encouraging a student to withhold from a parent such information.

• Establishes that classroom instruction by school personnel or third parties on sexual orientation or gender identity may not occur in prekindergarten through grade 8. In grades 9-12, such instruction must not occur in a manner that is not age-appropriate or developmentally appropriate for students in accordance with state standards.

• Requires each school district, at the beginning of the school year, to notify parents of each health care service offered at their student's school and the option to withhold consent or decline any specific service.

• Requires each school district to adopt procedures for a parent to notify the principal, or his or her designee, regarding specific concerns at his or her student's school about practices and procedures under s. 1001.42(8)(c), F.S., and the process for resolving those concerns within seven calendar days after notification by the parent.

OKEECHOBEE COUNTY SCHOOL BOARD NOTIFICATION OF SOCIAL SECURITY NUMBER COLLECTION AND USAGE

In compliance with Florida Statute 119.071(5), this document serves to notify you of the purpose for the collection of your child's social security number. The Okeechobee County School Board will collect and use your child's social security number only if specifically authorized by law to do so or when it is imperative for the performance of its duties and responsibilities as prescribed by law.

- State of Florida Bright Futures Scholarship Program
- Local scholarship applications (Take Stock in Children, etc.)
- Verification of Income Eligibility for Federal Free and Reduced Lunches
- Medicaid Reimbursement
- General Educational Development (GED) Application
- Social Security Income Verification and Assistance
- Developmental Services
- Data tracking for the Florida Education and Training Placement Program
- Managing Student Records in the Automated Student Database
- Matching of records between the Florida Department of Education and the Kindergarten screening data for Voluntary
 Pre-Kindergarten Provider Readiness Rate
- Reporting Excessive Absences to the Department of Motor Vehicles
- Documents and Reports for the Department of Juvenile Justice and law enforcement agencies as required
- The Florida Department of Health as required
- Forwarding records requests to other school districts where the student seeks to enroll or to request records of past attendance
- Dual Enrollment in college courses
- Other purposes specifically required or authorized by local, state or federal law

CONSIDER <u>PERFECT ATTENDANCE</u>; 180 DAYS OF SCHOOL EACH YEAR!

School attendance is the responsibility of the parent and student. Since there is a strong relationship between attendance and academic performance, it is important that parents take an active role in working with the school to ensure their child's attendance on a daily basis. State law requires that all students between the ages of six and eighteen attend school regularly. Failure to comply with this law could result in the arrest of the parent or legal guardian responsible for the child.

Absences are classified as excused or unexcused. School Board policy lists the reasons for which an absence may be excused.

Excused Absences:

- \cdot Illness or injury of the student
- · Illness or injury to the student's immediate family necessitating the student's absence
- · Death to a member of the student's family necessitating the student's absence
- · Recognized religious holidays of the specific faith of a student
- · Doctor and dental appointments of the student
- · Pre-arranged absences of educational value and with the principal's approval
- · Subpoena or forced absence by any law enforcement agency
- \cdot Major disaster that would justify absence in the judgment of the administration
- · Head lice, a maximum of two days per incident

It is the responsibility of the parent or guardian to provide written or oral notification indicating the reason for the absences within three (3) days of the student's return to school.

Unexcused Absences:

- Any absence which is not justified by the parent or guardian or for which the reason is unknown
- · Not attending class while on a school campus (skipping)
- In grades K-8, an accumulation of five unexcused tardies/early checkouts will convert to an unexcused absence.

These absences are considered when calculating absences towards truancy. In addition, these absences are considered when awarding perfect attendance.

· Final determination on whether an absence is excused or unexcused is the responsibility of the principal nces of Students Grade 9-12

Absences of Students Grade 9 -12

• Minors between 14 and 18 years of age who accumulate 15 unexcused absences in any 90-calendar-day period, will not be issued a learner's permit or will have their driver's license suspended.

READY TO START SCHOOL?

Please contact the administration office of the school you are zoned for based on your permanent home address. If you are uncertain of the school you are zoned for, you may contact the Director of Student Services, at (863) 462-5000 ext. 1060, to get that information. To enroll your child in school you must complete a registration packet provided by the school. The packet includes questions regarding your demographic information, requires proof of address and a copy of previous schooling information. In addition, before admitting a child to kindergarten, the principal shall require evidence that the child has attained the age at which he or she should be admitted in accordance with the provisions of subparagraph Florida Statute 1003.21 (1)(a)2. The district school superintendent may require evidence of the age of any child whom he or she believes to be within the limits of compulsory attendance as provided for by law. If the first prescribed evidence is not available, the next evidence obtainable as listed in (4) (a-g) will be required. The school district has a policy to provide for appropriate screening of its students for scoliosis at the proper age.

IMMUNIZATION REOUIREMENTS

Each child entering a Florida public or private school must present or have on file at the school, a Florida Certification of Immunization (Department of Health Form 680, copies are not accepted). Immunizations must be valid and up-to-date for age and grade level as required by the State of Florida. The following is a summary of these requirements.

Public/Non-Public Schools Kindergarten through 12th Grade:

- Four or five doses of diphtheria-tetanus-pertussis (DTaP) vaccine
- Two or three doses of hepatitis B (Hep B) vaccine Three, four, or five doses of IPV (with at least one dose of polio vaccine administered after the 4th birthday)
- Two doses of measles-mumps-rubella (MMR) vaccine
- Two doses of Varicella* for grades 2-11, one dose of Varicella for grade 12 only (for 2019-20 school year) Two doses of Varicella for K-12 for 2020-2021 school year and thereafter
- *Varicella vaccine is not required if there is a history of varicella documented by the healthcare provider.

Seventh Grade Requirement:

In addition to compliance with all other required immunizations, children entering, attending, or transferring to the seventh, eighth, or ninth grade in Florida schools must complete the following:
One dose of tetanus-diphtheria-pertussis (Tdap) vaccine

The original Florida Certification of Immunization (DH 680, copies are not accepted) must be used to document immunization requirements for admittance through grade 12.

This form must be completed with the child's name, date of birth, parents/guardians name, the name of the physician or clinic, physician or clinic address and the signature of physician or the authorized designee. Handwritten physician signatures will not be accepted as this form must be electronically certified. This form must show that the child is up-todate with the required immunizations. Handwritten dates for required immunizations will not be accepted. Any student transferring from another Florida school may be given a 30-day temporary exemption until the certification of immunization can be obtained from the previous school. If the record cannot be obtained from the previous school within this time frame, it is the parent's responsibility to provide such a copy. Any student from out-of-state must present an up-to-date Form 680 at time of enrollment. If you have any questions, please call the Florida Department of Health in Okeechobee County at (863) 462-5792.

School Physical Exam:

Each child who is entitled to admittance to pre-kindergarten or kindergarten, or is entitled to any other initial entrance into a public or non-public school in the state of Florida, must present a certification of a school entry physical examination performed within one year (12 months) prior to enrollment in school.

Any student transferring from another school in the United States may be given a 30-day temporary exemption until the certification of a school entry physical examination can be obtained from the previous school. If the record cannot be obtained from the previous school within this time frame, it is the parent's responsibility to provide such a copy. Any student from out-of-state must present an up-to-date Form 680 at time of enrollment.

WHAT IS THE SCHOOL HEALTH SERVICES PROGRAM?



TIPS FOR WALKING AND BIKING SAFELY:



PROTECTING CHILDREN FROM SEXUAL OFFENDERS AND PREDATORS:

- At the bus stop: Students and parents are responsible for safety and proper student behavior.
- Students must stand at least 10 feet back from the roadway while waiting.
 - Students must respect other people's property.
- Students must not push, shove, or engage in horseplay.
- Students must arrive at the bus stop at least five minutes prior to the scheduled pickup time.
- Students must wait for and get off the bus only at approved stop locations.
- Parents should supervise children at the stop.

During loading and unloading: Always stay away from the 10 foot "danger zone" around the bus, except when you are directed by the driver.

- NEVER pick up an object that you drop under or near the bus. Ask the driver for help.
- Always make sure the driver can see you, never walk behind the bus.
- Make sure clothing and backpacks have no loose drawstrings or long straps that could catch in the handrail or bus door.
- When you see the bus coming, stand at the stop and wait for the bus to come to a complete stop.
- Always wait for the driver to signal that it is safe to cross the road and/or load into the bus.
- When crossing a traffic lane, always look left, right, then left again; cross only if approaching traffic has stopped.
- Only board your assigned bus, unless other arrangements are approved by your school.
- Never approach a moving bus.

During the bus ride: Always follow the driver's directions.

- Never distract the driver unless there is immediate danger to you or others.
- Remain seated with your seat belt fastened, keep the aisles clear, always keep your arms, legs, and head inside the bus.
- Eating, drinking, and chewing gum are prohibited unless an exception has been approved for a trip approved by the Superintendent or designee.
- Never bring unauthorized items into the bus.
- Always wear your seat belt when one is available.
- Always show respect for your fellow students and bus driver.
- Keep conversation at a reasonable level and remain quiet at railroad crossings.
- Walking: Walk with an adult or responsible older child at all times.
- Children under 10 years old should cross the street only with an adult or when directed by a bus driver.
- Walk on the sidewalk if there is one.
- Walk facing the traffic, as far from the road/traffic as possible, if no sidewalk is available.
- Use traffic signals and marked crosswalks if available.
- Stop at the curb or edge of the road and look left, right and left for traffic before crossing the street.
- Walk; don't run.
- Give drivers time to see you before crossing the street.
- Keep looking for cars while you are crossing.
- Wear white clothing or reflectors when walking in the dark or in low light.

Biking: (Riders must follow Florida Traffic Laws.) Always wear a helmet that is properly fitted.

- Whenever possible, ride with an adult or responsible older student.
- Always obey all traffic signs and signals.
- Ride on the right side of the road or trail in a single file (one bicycle behind another).
- Ride in the same direction as other vehicles. Co straight across railroad tracks.
 - Always use proper hand signals when turning and stopping.
 - Yield to pedestrians and alert them with a bicycle bell or your voice when passing.
- Talk to your children about following these tips:
- Stay away from an unfamiliar person who is trying to trick you or force you to go with him or her.
- Let your parents and other trusted adults know about any suspicious person or situations.
- Learn to describe people and vehicles.
- Know where to run and how to forcibly resist capture.
- Scream to be seen and to scare a stranger away.
- Stay with a buddy, a group, or parents at the bus stop.
- Report anyone hanging around or passing by regularly.
- Walk or bike along a route that your parents have determined is safe.
- Lock the door and never tell callers you are home alone.

RIGHT TO KNOW Qualifications of Teachers

The Okeechobee County School Board is committed to providing information to you regarding your child's teacher and paraprofessional qualifications in a timely manner upon request. At any time, you may ask:

- If the teacher meets state qualifications and certification requirements for the grade level and subject he/she is teaching
- If the teacher has received an emergency or conditional certificate through which state qualifications
 were waived
- What undergraduate or graduate degrees the teacher holds, and major(s) or area(s) of concentration
- Whether your child receives help from a paraprofessional, and if so, his/her qualifications The Every Student Succeeds Act (ESSA), signed into law in December 2015, contains additional parent right to know requests, including:
- Information on policies regarding student participation in assessments
- Information on required assessments including: Subject matter tested, Purpose of the test, Source of the requirement (if applicable), Amount of time it takes students to complete the test, Time and format of distributing results.

All of the above information can be requested through your school principal.

BUS PASS PROCEDURE (SCHOOL BOARD POLICY 8.21)

All requests for use of an ongoing alternate bus stop location must be given in writing to the school annually. The alternate bus stop must be in the same attendance zone and the alternate stop will replace the home stop. Students will not be transported to different stops on different days of the week. For example, a parent may arrange for a student to be bused to the nearest existing bus stop to their work location or a sitter's home (assuming it is within the attendance zone of the school). The student will not be bused to that alternate stop on some days and directly to home on other days. If circumstances change (for example, due to a job change), a new request may be submitted. However, serial requests will not be considered.

OKEECHOBEE COUNTY SCHOOLS PROMOTION REQUIREMENTS

The promotion requirements for students in Okeechobee public schools are found in the Okeechobee County School Board Student Progression Plan.

Elementary School (grades K-5)

Students shall demonstrate satisfactory progress in reading and mathematics as measured by state assessments and locally determined criteria

In To be promoted to grade 4, a student must score a Level 2 or higher on the statewide, standardized English Language Arts assessment required under s.1008.22 for grade 3.

Middle School (grades 6-8)

Middle grades students must earn passing grades in ELA, math, science, and social studies for three grading periods of the school year (three out of four quarters per course). To be promoted from middle school a student must complete:

3 middle grades or higher courses in English Language Arts

3 middle grades or higher courses in mathematics

3 middle grades or higher courses in social studies (One of these courses must be at least a one-semester or year-long course in civics.)

3 middle grades or higher courses in science

⊠ 1 course in career and education planning

High School (grades 9-12)

Promotion to the next grade level in high school is dependent on a student earning the required number of credits.

TESTING REQUIREMENTS

- Florida Assessment of Student Thinking (FAST) will be administered three times per year in grades VPK through grade 10 English Language Arts and VPK through grade 8 Mathematics.
 - The end-of-course assessments are computer-based tests designed to measure student achievement of the specified standards for middle and high school level courses in Biology 1, Civics, US History, Algebra 1, and Geometry.
 - The statewide science assessment measures student success with the Next Generation Sunshine State Standards and includes assessments in grades 5 and 8.
- All students must participate in the statewide assessments for the course(s) in which he/she is enrolled. MCKINNEY-VENTO HOMELESS ASSISTANCE ACT

The Federal McKinney-Vento Homeless Assistance Act states that children and youth who lack a fixed, regular, and adequate nighttime residence are considered homeless. If, due to a loss of housing, a child must live in a shelter, motel, vehicle, or campground, on the street, in abandoned buildings, or doubled-up with relatives or friends, then he/she is eligible to receive services provided under the McKinney-Vento Act. The McKinney-Vento Education for Homeless Children and Youth Program is designed to address the problems that homeless children and youth have faced in enrolling, attending, and succeeding in school. Under this program, state educational agencies must ensure that each homeless child and youth has equal access to the same free, appropriate public education, including a public preschool education, as other children and youth.

Under McKinney-Vento, children (PreK-12) have the right to:

- Continue to attend the school they last attended before they lost their housing (school of origin), if that is the parent/guardian's choice and is in the child's best interest, or the school which is zoned for their temporary residence.
- Enroll and attend classes immediately while the school arranges for the transfer of school and immunization records and other required enrollment documents.
- If necessary, enroll and attend classes in the school selected by the parent/guardian (school of origin or zoned school), while the school and the parent/guardian seek to resolve a dispute over which school is in the best interest of the child - NOTE: This does not mean any school in the district, only the school of origin or zoned school.
- Receive transportation to the school of origin (if a parent/guardian requests such transportation).
- Participate in any school programs and receive any school services for which they qualify.

Cell Phone Policy following the signing of House Bill 379 by Governor DeSantis

We want to inform parents and students. Elementary and Middle Schools didn't change. High School students will notice a difference. What does this new legislation look like in our schools?

Elementary Schools:

Central Elementary, Everglades Elementary, North Elementary, Seminole Elementary, and South

Elementary:

Cell phones will be silenced and out-of-sight during the school day. A student may not use a wireless communication device during instructional time, except when expressly directed by a teacher solely for educational purposes. (HB379).

Middle Schools:

Okeechobee Achievement Academy, Osceola Middle School, and Yearling Middle School: Cell phones will be silenced and out-of-sight during the school day. Lunchtime access to phones will be at the discretion of school site administrators. A student may not use a wireless communication device during instructional time, except when expressly directed by a teacher solely for educational purposes. (HB379).

High Schools:

Okeechobee Freshman Campus and Okeechobee High School:

Cell phones will be silenced and out-of-sight during instructional time (class periods).

Use will be limited to transitions (class changes) and lunchtimes.

A student may not use a wireless communication device during instructional time, except when expressly directed by a teacher solely for educational purposes. (HB379).

At all school levels:

Office phones, at each school site, can be used if a student needs a parent during the school day. Students will be expected to follow the teacher's directions for cell phone storage and times of appropriate use.

HIGH SCHOOL

High School includes grades 9 - 12 and is designed to prepare students to meet the challenges of adulthood by developing their academic, leadership, and citizenship skills. At the high school level, students start making choices about the design of their academic programs. They are able to customize their course of study with a career in mind, or may choose to take a variety of electives in order to help them make a decision about their future career path. For those students who choose to attend college after graduation, the increased rigor of the academic classes will help to prepare them for a less restrictive more self-directed study environment.

- Okeechobee High School/Freshman Campus serves only ninth graders. OFC's main building is the result of a historical renovation of the original Okeechobee High School building.
- Okeechobee High School, home of the Brahmans, serves tenth through twelfth graders.
- Okeechobee Achievement Academy serves students in need of additional support.

Instructional Levels

At each secondary grade level from 8th through 12th grades, there are established optional instructional program levels within the subject areas. These instructional levels are identified in the Florida Course Code Directory. Students are assigned to the levels based on individual evaluation of the student's academic achievement level. If the student is performing below grade level they will be assigned to a remedial class. If they are prepared to experience a more rigorous academic opportunity they may be scheduled into an honors curriculum.

At the high school level, if your child's cumulative grade point average falls below 2.5 on a 4.0 scale you will be notified that your child is at risk of not meeting the graduation standards and a conference will be suggested.

Students who score at Level 1 on the ELA portion of the FAST (administration 3) will be offered an intensive reading course the following year. Level 2 readers will be offered an intensive reading course or a content area course in which reading strategies are delivered. High school students scoring at Level 1 or Level 2 on FAST Algebra may be offered remediation the following year.

Enrollment Termination

A student who attains the age of 16 years during the school year is not subject to compulsory school attendance beyond the date upon which he or she attains that age if the student files a formal declaration of intent to terminate school enrollment with the District School Board. Public school students who have attained the age of 16 years and who have not graduated are subject to compulsory school attendance until the formal declaration of intent is filed with the District School Board. Florida Statutes 1003.21.

The declaration must acknowledge that terminating school enrollment is likely to reduce the student's earning potential and must be signed by the student and the student's parent. The school district must notify the student's parent of receipt of the student's declaration of intent to terminate school enrollment. The student's school counselor or other school personnel must conduct an exit interview with the student to determine the reasons for the student's decision to terminate school enrollment and actions that could be taken to keep the student in school. The student must be informed of opportunities to continue his or her education in a different environment, including, but not limited to, adult education and GED test preparation. Additionally, the student must complete a survey in a format prescribed by the Department of Education to provide data on student reasons for terminating enrollment and actions taken by schools to keep students enrolled. REOUIREMENTS FOR GRADUATION

I. Graduating seniors

Florida law allows students entering grade nine to choose from one of five options to earn a standard high school diploma:

- 24-credit program <u>Florida Statutes 1003.4282 (IIB1);</u> 18-credit, Academically Challenging Curriculum to Enhance Learning (ACCEL) option <u>Florida Statutes</u> . 1002.3105
- Career and Technical Education (CTE) Pathway 1003.4282 F.S https://www.fldoe.org/academics/careeradult-edu/career-tech-edu/pathways-option.stml

In addition to the three options available for students to earn a standard diploma listed above, Rule 6A 1.09963, Florida Administrative Code, High School Graduation Requirements for Students with Disabilities, outlines two additional options that students with disabilities may complete. See Section VII, Graduation for **Exceptional Education Students**

EARLY GRADUATION

Students who complete a minimum of 24 credits, achieve a cumulative grade point average of 2.0 on a 4.0 scale and earn a passing score on the statewide assessments required for high school have an option to graduate in fewer than eight semesters (four years). A student who graduates from high school midyear may receive an initial Bright Futures Scholarship award during the spring term following the student's graduation, as long as the student applies for the scholarship award no later than August 31 of the student's graduation year.

EXTRA-CURRICULAR ACTIVITIES (INCLUDING ATHLETICS AND BAND)

Students who want to participate in an extra-curricular program must practice good self-control and good citizenship. In order to maintain eligibility a student must earn a 2.0 or higher cumulative GPA depending chosen activity.

POST-HIGH SCHOOL EXPERIENCE

It is the goal of the Okeechobee County School System that each graduate is prepared to enter some post-secondary institution or the workforce upon graduation. This may include any university, community college, vocational institution, technical institution, internship program, the military, or a jobtraining program. In order to enter a college a student must submit ACT or SAT scores that meet minimum requirements. In order to take advantage of these experiences the student may be required or advised to take one or more of the following standardized tests:

- American College Testing Program (ACT) This test is used for college admission and is de signed to measure classroom achievement in four areas: English, mathematics, reading, and science.
- Armed Services Vocational Aptitude Battery (ASVAB) Is a test which identifies a students skills and competencies in preparing for the workforce.
- Postsecondary College Readiness Test (PERT) 10th and 11th graders A test administered to assess their basic computation and communication skills in preparation for their entry into a degree program at a state college or university. The test includes Reading, Writing, and basic Mathematics sections.
- Pre-Scholastic Aptitude Test (PSAT) designed for sophomores or juniors (and designated freshman). It can be used as practice for the SAT, which the student will take the following year. In the 11th grade it is used to determine which students will participate in the National Merit Scholarship Program.
- Scholastic Aptitude Test (SAT) This test is used for college admission and is designed to measure general verbal and mathematical abilities.

The 28 colleges of the Florida College System serve more than

650,000 students. Colleges offer affordable and stackable workforce credentials including certificate programs, associate in science degrees and associate in arts degrees, which transfer to a bachelor's degree program. All colleges also offer workforce bachelor's degree programs in areas of high demand. All Florida College System institutions have open-door admissions for students who earned a standard high school diploma or an equivalent diploma, or earned college credit.

EARNING COLLEGE CREDIT IN HIGH SCHOOL

Students may earn college credit in high school through any of the following programs for which they are eligible:

Advanced Placement

Advanced Placement (AP) is the enrollment of an eligible secondary student in a course offered by the Advanced Placement Program administered by the College Board. Postsecondary credit for an AP course may be awarded. Students should consult their college requirements/policies. Students who are enrolled in an Advanced Placement course and earn the minimum score necessary to earn college credit are not required to take the state end-of-course assessment for that subject.

Credit Acceleration Program (CAP)

The purpose of the Credit Acceleration Program (CAP) is to allow a secondary student to earn high school credit in courses required for high school graduation through passage of an end of course assessment in Algebra I, Biology, Geometry, and/or United States History or an Advanced Placement or College Level Examination Program (CLEP) test. Notwithstanding Florida Statutes 1003.436, definition of "credit", a school district shall award course credit to a student who is not enrolled in the course, or who has not completed the course, if the student attains a passing score on the corresponding end of course assessment. Advanced Placement exam or CLEP test. The district shall permit a public school or home education student who is not enrolled in the course, or who has not completed the course, to take the assessment or exam during the regular administration of the assessment or exam.

Dual Enrollment

The dual enrollment program is defined as the enrollment of an eligible secondary student or home education student in a postsecondary course creditable toward high school completion and a career certificate or an associate or baccalaureate degree. The Okeechobee County School Board and Indian River State College operate under a Dual Enrollment Contract. College credit and vocational certificate courses may be offered to high school students pending the approval of the high school principal. Students enrolled in an approved dual enrollment course are exempt from the payment of registration, tuition, and laboratory fees a. Requirements for students to be admitted in a dual enrollment course:

(1) Students must have completed at least one semester of 9th grade and have earned a minimum of 4 high school credits, and a cumulative unweighted high school grade point average of 3.0 or better and/or the approval of their high school principal.

(2) Students must meet the same entrance

requirements as students desiring to enroll in the same courses on the college campus and have the approval of the high school principal.

(3) Dual enrollment course offerings are limited to approved courses at Indian River State College. Students must receive prior approval from their principal to enroll. Courses not taken at IRSC are not covered by the Dual Enrollment Contract and therefore are not eligible for tuition and instructional materials reimbursement by OCSB. This includes talent identification programs, college summer programs, summer camps and courses at schools other than IRSC.

(4) College ready scores are required for all students participating in dual enrollment Grades earned in dual enrollment courses will carry the same grade weight as Advanced Placement courses when grade point averages are calculated.

(5) Any college credit course comprising 3 credits or higher and/or any vocational clock hour course comprising 75 hours or higher that is listed in the State Common Course Numbering System (SCNS) for postsecondary credit can be considered for Dual Enrollment. Courses that meet high school graduation requirements are listed in the DUAL ENROLLMENT COURSE EQUIVALENCY LIST. All high schools shall accept these post-secondary courses toward meeting the requirements of Section 1003.43, F.S.

Early College Admissions (Full-Time College)

Students may enter college full time during their senior year if the following criteria are met:

a. The student must successfully complete the 11th grade with enough credits to be classified as a senior.
b. The student must have achieved at least a 3.0 cumulative unweighted grade point average during his/her sophomore and junior year.

c. The student must have the approval of the high school principal.

d. Students must meet the same entrance requirements as students desiring to enroll in the same courses on the college campus, have earned a college-ready score as indicated above, and have the approval of the high school principal.

e. Students entering the Early College Admission Program may earn a high school diploma to be awarded with the student's class at graduation or at a later time based on the following:

- The student must demonstrate mastery of skills measured by state standardized assessments.
- The student must earn sufficient college credit to fulfill the remaining high school graduation requirements (based on three semester hours equaling one-half high school credit).
- The student must maintain at least a 2.0 GPA in college courses.

VIRTUAL SCHOOL: WHICH OPTION IS RIGHT FOR ME? Okeechobee Virtual School

Okeechobee Virtual School (OVS) was created as yet another choice for a quality education within the district. OVS has partnered with Florida Virtual School to offer high quality curriculum yet have access to local teachers. OVS offers all core courses which are required for graduation for grades K-12, and many elective courses including some Advanced Placement Courses(AP). There are two options for OVS:

With OVS Full Time, secondary only, you can:

- Take courses for FREE, if you are a resident of Okeechobee County or in a surrounding county with a waiver from your home county.
- The teachers are employees of the Okeechobee County School Board and therefore held to the OCSB standards for quality.
- Take a full-time, online, course load at home.
- Do course work online, but maintain a traditional, 180-day school calendar and schedule.
- Take up to six courses per semester.
- Be a full-time, online student.

With OVS Flex (secondary only), you can:

- Take courses for FREE, if you are a resident of Okeechobee County or in a surrounding county with a waiver from your home county.
- The teachers are employees of the Okeechobee County School Board and therefore held to the OCSB standards for quality.
- Open Enrollment Windows will be advertised but will typically be 30 days prior to a semester beginning.
- Take a single course or multiple courses to supplement your schedule.
- Keep your traditional school as the school of record.
- The traditional school keeps your transcript and determines when graduation requirements are met.
- Meet online course graduation requirements.
- Homeschool students are registered with the Okeechobee County School District. That means the records are maintained by the school district and the parent/guardian is responsible for curriculum.

As a homeschool student, we know that you have choices in how and when you learn. So, whether you are looking for a single course or a full-time solution, you and your family can enjoy more flexibility with OVS.

Drop/Withdrawal

Okeechobee Virtual School sets high expectations for the success of its students. We are committed to meeting the needs of all students and will work tirelessly to facilitate student success. To ensure continuity of learning, students must submit assignments in their course on a weekly basis and maintain regular contact with their instructors.

- Any student who does not make progress in the course for a period of 14 calendar days and has not made prior arrangements with his/her instructor will be scheduled for a Success conference to organize additional support and progress monitoring.
- The assistant principal will work with the student, parent, and the course instructor to create a Success Plan for the student.
- Failure to respond to attempts to contact the student, or failure to adhere to the Success Plan created by the student and family may result in Administrative Removal from the course with a W/Withdrawn-F grade.

Note: W/Withdrawn- No grade: (No academic penalty) Student must withdraw during the 14-day grace period to receive no penalty. W/Withdrawn- F grade: Student withdrew with unsatisfactory performance after the 14day grace period.

CAREER AND TECHNICAL EDUCATION

All secondary schools offer multiple career and technical education programs designed to provide a link between academic performance and the workplace. The goal of Career Education is to provide students with real-world, hands-on instruction that gives meaning and incentive to learn the material presented in academic classes.

For School-to-Career planning, <u>FloridaShines</u> works with the state's 40 colleges and universities and other partners to help you succeed in school and beyond. Check your transcript. Register for an online course. Search libraries across the state. And a whole lot more. All designed to help Florida students shine.

The Florida Virtual Campus (FLVC) is a statewide provider of innovative educational services for Florida's K-20 community. Working collaboratively with the state's 12 public universities, 28 public colleges, K-12 school districts, and other partners, FLVC provides services that help students succeed in school and life after graduation. Those services include:

- An array of academic advising, career readiness, and distance learning resources for students and parents, available through the FloridaShines website
- Support for the academic libraries at the state's public colleges and universities, including a discovery tool used by students and faculty to access library resources and an integrated library management system used by library staff
- Tools and training materials used by academic advisors, distance learning staff, librarians, and other staff at Florida's public colleges and universities to provide services to their students and faculties.

After selecting a career, students at OHS may choose to enroll in the following programs:

- Automotive Maintenance and Light Repair
- Technical Agriculture Operations
- Building Construction Technology
- Animal Science and Services
- Digital Design
- Aquaculture
- Nursing Assistant
- Agricultural Communications



After completing a program, students may gain additional college credits with Indian River State College through an articulation agreement.

To explore even more careers, upperclassmen may decide to participate in the internship program. After researching an occupation and completing a resume, students have an opportunity to intern in businesses throughout Okeechobee County.

By providing such comprehensive services in career and technical education, students should be able to select a career based on their interests, enroll in courses that provide technical skills needed in that career area, potentially earn college credit, and, most importantly, enter employment well prepared to work.

All Okeechobee County School District students are afforded the opportunity to enroll in the Career and Technical Education programs beginning in the eight or ninth grade. The various programs and courses within those programs currently offered are located in the CTE Guide on the district website okee.k12.fl.us, on the Career and Technical Education page. Each program offers work-based learning opportunities through on the job training courses. The CTE Graduation Pathway is included within this parent guide. The CTE Graduation Pathway graduation option includes the following:

- Successfully complete a minimum of 18 credits.
- Have a minimum, cumulative GPA of at least a 2.0 on a 4.0 scale.
- Meet the requirements of
 - 4 English credits (including the statewide grade 10 Reading assessment or the grade 10 ELA assessment, or earn a concordant score)
 - 4 Math credits (including the statewide Algebra I EOC assessment, or earn a comparative score)
 - 3 Science credits
 - 3 Social studies credits
- Complete two credits in career and technical education. The courses must result in a program completion and an industry certification.
- Complete two credits in work-based learning programs. A student may substitute up to two
 credits of electives, including one-half credit in financial literacy, for work-based learning
 program courses to fulfill this requirement.

Students are also able to complete various foundational and soft-skills credentialing programs via the Florida Ready to Work website - floridareadytowork.com. Parents and students can contact their school counselor for more information and to seek help signing up for the courses. Parents can contact the certified school counselor at the Okeechobee Freshman Campus (863) 462-5288, for more information on any of these items for further assistance and guidance.



COLLEGE & CAREER PLANNING SERVICES

The Okeechobee High School College and Career Center offers a variety of services for students and families to plan for graduation and college and career success. Starting in 8th grade, students participate in a Career Fair and attend a spring tour of OHS Career and Technical programs. Parents of Freshmen and Sophomores are offered evening scheduling to increase involvement in their student's graduation plan. Dual Enrollment (DE) classes are offered in a variety of academic subjects and career fields. PERT, SAT, and ACT are offered at various times of the year to determine college and career readiness. Sophomores take PSAT in the fall. Juniors take PSAT/NMSQT to enter in the National Merit Scholarship competition. Juniors take SAT School Day in March. All students have access to Khan Academy for free SAT test prep. OHS hosts College Fair Day and Career Day in the fall and Financial Aid Night in January. FAFSA Nights occur frequently for Seniors and their parents to assist with the Federal Student Aid application. The ASVAB (Military) test is given twice a year. Contact the College and Career Center in the Guidance office for more information.

EDUCATIONAL CHOICE IS AN OPTION

Controlled Open Enrollment

The Okeechobee County School Board allows parents to declare school attendance preferences. This system is called Controlled Open Enrollment. Parents may choose to apply for a "zone waiver" for any school of their choice that has not reached capacity. Zone waivers are approved through a lottery system. For any student who attends a school on a zone waiver, the parents must provide transportation to and from school. For more information about Controlled Open Enrollment, please contact the Student Services Office at 863-462-5000 ext. 1060.

Students may be assigned to the **"alternative school"** if they have been in trouble in the community or need specialized programs.

A parent of a special education student or a student with a 504 plan may request a different public school or receive a scholarship to attend a private school through the "Family Empowerment Scholarship Program". In order to take advantage of this option parents can contact the Student Services Office at (863) 462-5000 Ext. 1060 for more information. You can access information at www.floridaschoolchoice.org.

A parent may choose to enroll their child (grades K-12) in Florida Virtual School internet computer-based public school. Contact your child's School Counselor for more information.

Parents also have a choice of enrolling their child in a "**Home School Program**". They are responsible for educating their own child and reporting annually to the superintendent about their progress. Information on the Home Education Program is available from the county office (863) 462-5000 Ext. 1060.

ENGLISH LANGUAGE LEARNERS (ELL)

Students identified as English Language Learners are served according to provisions of the Okeechobee County School Board District ELL Plan. This plan establishes procedures for identification, assessment, comprehensive instruction, parental involvement and personnel training regarding services to students with limited English proficiency. Copies of the District ELL Plan are available at the School Board Office, room 306. In addition, parents/guardians of ELL students are encouraged to participate in our District Parent Leadership Council. For more information on our ELL program contact 462-5000, extension 1060.

MTSS/SCHOOL-BASED INTERVENTION AND SUPPORT

Every child's path to a successful goal of a diploma is not always the same. Some children may need additional supports to master that goal. During your child's school years, you will be meeting with the staff of your child's school to discuss the specific issues and educational needs of your child. A teacher along with an administrator and/or school counselor may request to have a team of professionals meet to discuss your child's academic, communication, behavior, or emotional concerns. The different teams are called the Grade Content Team or the School Problem Solving Team (SPS Team). The team reviews your child's records and progress and assists in identifying and analyzing concerns. Interventions (or tiered levels) are recommended by the team, and a plan to monitor your child's response and determine the level of progress is developed. The team regularly reviews your child's response to interventions. This is known as the Multi-Tiered System of Supports (MTSS). MTSS is a framework that helps promote the success of every child. Okeechobee County Schools uses an array of academic monitoring tools and assessments to determine the best educational decisions for students. In addition, behavioral concerns are addressed through the Positive Behavior Intervention and Support (PBIS) initiative. The goal of PBIS is to build effective school-wide environments in which positive behavior promotes better academic success. Monthly mental health and wellness videos that are created using the state mandated five-hour resiliency focused model of required instruction are also used in our district to help promote whole child wellness. Contact a school administrator for more information.

Sometimes a student, despite appropriate interventions, continues to exhibit academic and/or behavioral concerns. In those cases, the SPS Team may invite the a resources specialist and/or a board certified behavioral analyst to work with the team in developing Tier 3 interventions. After reviewing Tier 3 data the team may determine that futher assessment is needed. This assessment will help determine if your child is eligible for Exceptional Students Education (ESE) services provided by the Individuals with Disabilities Education Information Act (IDEIA). Each school in our district, in addition to a counselor, has a school psychologist, ESE Resource Specialist and a behavior interventionist that you may contact. This person will help you with any concerns or questions regarding the interventions, referral for testing process, the actual testing or ESE programs, and services in which your child is involved. Contact the ESE office (863) 462-5000 Ext. 1055. In addition to tiered interventions through MTSS, there is a district school social worker and three crisis counselors available to all students needing support for emotional and/or mental health needs. If interested in these services contact the Department of Mental Health and Behavioral Supports office (863) 462-5000 Ext. 1099, or contact your child's school counselor to make a referral.

In line with Senate Bill 7030 written into law in 2019, Okeechobee County Schools participates in a Universal Screening process of all students. This process includes a mental health/behavioral form supported by the Positive Behavioral Interventions and Supports (PBIS) system. It will be used to help school administration, leaders, and teachers nominate students based on the prevalence and early development of both externalizing (i.e. manipulating behaviors, disrespect, aggression, etc.) and internalizing behaviors (i.e. isolating behaviors, anxiety, depression, etc.). The form will be available for all students; however, the district will adopt a triage process where the students with the highest scores will be nominated for immediate Tier 2 or Tier 3 supports. This process will happen twice per school year. Teachers will collect data and present this data to the School Leadership Team who will then create a master list of students in need of tiered supports. School staff as well as school and district based mental health professionals and community partners will facilitate interventions based on the needs of the students. All intervention plans will require parent notification.

IF YOUR CHILD NEEDS EXTRA HELP IN SCHOOL...

He/she may need additional services. The Individuals with Disabilities Act (IDEA) allows you and or their teacher to refer your student for evaluation. You will be a part of the evaluation and eligibility teams that determine eligibility and plan for programming to meet your students' needs.

- You may ask your students school to evaluate your child for free if you think they may need special educational services.
- If your student qualifies as a student with a disability, you will be a part of the Individual Education Plan (IEP) team to determine the services needed for your student.
- You will be provided with your procedural safeguards to inform you of what your rights are under IDEA.

IF YOUR CHILD IS PERFORMING AT A HIGH LEVEL

If your student has high grades, test scores or possibly a special talent, they may need the enrichment class for gifted students. You and or their teacher can refer them for evaluation. If your student meets the evaluation criteria as a gifted student you would be part of the Education Plan (EP) team to determine what services would address their needs. Your student would then receive instruction in an enrichment setting.

WHAT ARE ACCOMMODATIONS?

The term "accommodation" may be used to describe an alteration of environment, curriculum format, or equipment that allows an individual with a disability to gain access to general education curriculum or complete assigned tasks. Examples include but are not limited to extended time on assignments or assessments, breaks for movement, instruction in small group and possibly assistive technology. The IEP team will determine what accommodations each student requires to be successful. These accommodations will be included in the IEP and will be provided in all academic settings.

SECTION 504

In order to qualify for a 504 plan, the child must meet the criteria set forth in the federal law for identification as an individual with a disability: Section 504 defines a person with a disability as "any person who has a physical or mental impairment which substantially limits one or more major life activities". Section 504 requires agencies to provide individuals with disabilities an equal opportunity to participate in their programs and benefit from their services. Depending on a student's individual needs, services may include, but are not limited to, extended time on assignments and assessments, breaks, counseling, as well as training in study strategies, organizational skills, and time management.
