Amendment of Board Policy 4.48 **Virtual Instruction**

- I. This policy provides information on certifications and assessments for the virtual instruction graduation requirement.
- II. Proposed revisions include the addition of certifications and assessments that meet eligibility requirements.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 1000.04, 1001.20, 1001.42, 1002.20, 1002.321, 1002.37, 1002.45, 1002.455, 1003.02, 1003.4282, 1003.498, 1006.29, 1007.27, 1011.62.

Amendment of Board Policy 5.21 **Requirements for Original Entry**

- I. This policy outlines requirements for initial entry of students.
- II. Proposed revisions to policy add mental health services; adds 1006.07 F.S.
- III. Legal authority for this policy is F.S. 1001.41, 1001.42. Laws implemented are 1001.43, 1003.01, 1003.21, 1006.07, 1003.22 F.S.; State Board of Education Rules: 6A-6.024
- IV. This policy amendment will not affect individuals from an economic standpoint.

Amendment of Board Policy 5.32* **Zero Tolerance for School Related Crimes**

- I. This policy is required by Florida Statute.
- II. Proposed revisions to policy add consultation with law enforcement.

Amendment of Board Policy 6.58* **Report of Misconduct**

- I. This policy provides guidelines for reporting alleged employee misconduct that affects the health, safety, or welfare of a student.
- II. Proposed revisions reflect changes in law regarding sexual misconduct.
